



## TERMS & CONDITIONS

### Triumph's Review and Win Competition 2023

#### Terms and Conditions

2. Information on how to enter and prizes form part of the terms and conditions of entry. Entry into the competition is deemed acceptance of these conditions of entry. The competition commences at 12.01am AEST on Sunday 1<sup>st</sup> January 2023 and ends at 11:59pm AEST on Sunday 31<sup>st</sup> December 2023 ("Promotion Period").
3. To enter, an entrant must rate and review a product during the Competition Period in the manner required, including by providing their full name and valid email address. All valid entries received will be placed into a random electronic prize draw.
4. Entry into this competition is open to all Australian and New Zealand residents aged eighteen (18) years and over. Employees of Triumph International AU/NZ or any of their related bodies corporate, and their immediate families, associated agencies and companies are not eligible to enter the competition.
5. Entrants must review a product that they own (that is available for review on [au.triumph.com](http://au.triumph.com) or [nz.triumph.com](http://nz.triumph.com)). Each product review submitted will provide the entrant with one (1) entry.
