



## EVENT DETAILS

Dress up or dress down, there will be a combination of fun to extreme obstacles to run, crawl or walk the course. Young or old, it's not a race and an event for everyone! It is all about having fun, making memories and you can elect to bypass any of the obstacles.

However, there is a \$1,000 cash prize for the team with the fastest time!

Participants arrive at the Showgrounds at least 45 minutes to one hour prior to their start times so we can get you properly registered. Then gather at the starting area to warm up and get psyched!

Your team will run 'within' the hour block you preselected. Waves of teams will run every 3-5 minutes of that hour, so thanks in advance for your patience!

Please respect the formula of the event, the running schedule and time. Don't be late and thanks AGAIN for your patience!

Once at the starting area, the MC will give you a brief run down of the course and run guidelines, then lead you in a group stretch and get you psyched up some more!

## WAIVER AND INDEMNITY FORM

1. I acknowledge and agree that participation in the Top End Ninja Obstacle Course event organised by Darwin Life Pty Ltd (ABN18140126147) may carry with it certain inherent risks and dangers that cannot be eliminated completely ranging from risk of minor discomfort to catastrophic injuries including permanent disability and death.
2. I assume full and complete risk and responsibility that may occur at participating in the event, including, but not limited to, my own actions or inactions, the actions or inactions of others (including participants, staff or spectators) including any discomfort, illness, injury, accident, falls, infection, completing any an all obstacles, defective equipment, the effects of weather (including high heat/cold and/or humidity), health risks (including but not limited to overexertion, dehydration, fatigue, lack of fitness or conditioning).
3. I certify that I am physically, mentally and medically able and have no medical condition that would make participation in the event more hazardous. I agree to exercise personal restraint and not take any unnecessary risks. If I am pregnant, disabled in any way or have recently suffered an illness, injury or impairment, I should have or did consult a physician before participating in the event.
4. I agree to abide by all instructions given by officials, staff, volunteers, representatives and comply with all posted rules and warnings.
5. I understand, agree and accept that some obstacles may go through water that has not been tested for chemicals, disease or contamination and that the event may contain wild animals, insects and plants.
6. I agree not to consume alcohol, ingest or use any substance, legal or illegal, medicinal or recreational, known or suspected to cause physical and mental impairment prior to or during the event. Prior to taking any medicines before the event, I will consult with a medical professional about possible side effects.
7. I consent to medical care and transportation in order to obtain treatment in the event of injury to me during the event, as volunteers or medical professionals may deem appropriate.
8. I understand that this document extends to any liability arising out of or in any way connected with the medical treatment and transportation provided in the event of an emergency and/or injury to me.
9. I understand that no medical care may be available, but if it is, I assume liability for any and all medical expenses incurred as a result of my

10. I understand and agree to exhibit appropriate behaviour at all times and to obey all local, state and federal civil and criminal laws at all times while participant in or attending the event. I will not use lewd and inappropriate language and gestures and acknowledge I may be asked to leave if I do use such.

I understand that Darwin Life Pty Ltd, including its employees and agents can dismiss me, without refund, should my behaviour endanger the safety of or negatively affect the event, another person, facility or property of any kind.   16. I am at least 18 years old OR I am at least 5 years old and my Parent/Guardian has reviewed this waiver and consented to its terms.
