**Dear Customer** 

Beaver Brands has learned of a printing error with the swing tags and manual for both the (BK061215TRAD) & (BK061015PRO). The swing tags and manual indicate a capacity of 160kg, however, the actual contents within these kits are rated at 140kg.

### **Affected Stock**

- Kits purchased after 2<sup>nd</sup> MARCH 2021 OR
- Kits with manufactured date after JUNE 2021

Beaver Brands advises, if you have purchased an affected kit, remove the kits from service immediately, and follow the steps below. You can contact Beaver Brands directly for replacement swing tags and manual or download them directly from the Beaver website.

**Distributors**: Upon receipt of this Notice, immediately inspect your Kits:

<u>Step 1:</u> Locate the swing tag, if swing tag is still attached to the kit continue to remove and discard. If the swing tag has already been removed check to ensure the swing tag is not located inside the bag, if located proceed to discard.

Step 2. Open the bag and locate the user manual and remove from bag, then discard.

<u>Step 3.</u> Once both swing tag and manual have been removed and discarded, proceed to the links below and download and print tags and manual. These can then be inserted into the bag which can then be resealed. Alternatively contact Beaver Brands and advise the quantity of replacement manual and swing tags required for replacement. 
