1. Period:

**Five years warranty, for the following products:**

T393 - Three-point latching exit device

T395 - Rim panic exit device - Touch series - Fire resistant.

T240 - Emergency touch pad

**Two years warranty, for the following products:**

T705 - Electric strike door (electrical parts excluded)

T850M - Eco outside lever without cylinder

T870 - Outside pull handle with key

**Lifetime warranty, for the following products:**

T210 - Door sequence selector for double doors

T370 - Accessories for glass doors push & touch series

2. Electrified exit devices and other electrified products including electronic supplies: 12 months since the date of the sale.

3. To have access to the warranty it is necessary for the user to prove the purchase of the product with the presentation of bills and purchase receipt, with the demanded product being this delivered to BLINCER S.R.L for its revision and it will have to possess the label specifying lot number and date of elaboration.

4. This warranty is extensive to all countries where the products are distributed by the company or an authorized distributor.

5. Conformity with the product is warranted according to the specific use for which it was designed. For the validity of this warranty It is a condition that the installation of the product is carried out by trained personnel following the instructions indicated in the installation manual that comes with the product.

6. The buyer will have to inform the company immediately, by fax or e-mail, any failure the product has during the limited warranty's time frame, in which case the company will be able to opt between:

a) Repairing the product to correct its malfunctions or deficiencies.

b) Delivering a replacement piece of the same characteristics, for both cases the reposition or replacement will take place in the company.

The company won't be held responsible of any direct or indirect costs related to the installation, desinstallation and transfer of the defectuous products.

Both cases apply as long as the buyer and/or the persons he has hired to get the product working have stored, instaled, maintained or operated the product respecting good industry practices, also completing the specific recommendations of the company.

7. The accessories and products provided by the company, but fabricated by others, will only have the guarantee that the original manufacturers have transmitted to the company and that can be transmitted to the buyer.

8. The company does not take responsibility for fixings, substitutions, adjustments and/or labor costs, generated by the product or made in the product by the buyer or third parties without the previous approval, in paper, by the company.

The effects of corrosion and erosion, as well as the wear made by the normal use of the product, are expressly excluded from this warranty.

9. This warranty of operation is expressly limited to what is specifically detailed in this proposal. The company does not bring any other warranty or representation of any kind, express or implicit. No agent, representative, distributor or employee of the company has the authority to increase or alter the obligations of this limited warranty. The buyer must not operate on a product that is considered defectuous without previously notifying the company in a written manner of their intention to do so. Otherwise, any use of the product will only be the buyer's responsibility and risk and will not be covered by this limited warranty.
