




How to Use the Remote Control

01 Power Button

Press and hold the power button for 2 seconds to turn the device on/off. Powering it up will automatically restore the previous timer settings and mode. On the first use of the device, the Daily Skin Care mode will automatically be activated with a default timer set to 10 minutes.

02 Mode Button

The mode that was previously used is remembered by default. Press the button briefly to cycle through the 4 available modes:

Daily Skin Care, Anti-Acne, Soothing, and Skin-Brightening.

03 Timer Button

The last timer setting that was previously used is remembered by default. Press the button briefly to adjust the timer duration. There are 3 options available: 10 minutes, 20 minutes, and 30 minutes.

Prohibited Use

Caution: This product is not suitable for individuals belonging to any of the following groups:

- Pregnant, planning to conceive, or breastfeeding
- Individuals with photosensitive skin or are taking medications that may cause photosensitivity
- People with hereditary skin conditions such as lupus, photosensitive eczema, or vitiligo
- •Individuals diagnosed as ineligible for this product

Before using the product for the first time, please conduct a photosensitivity test:

- Place the device on your arm and switch it on for 10 minutes of exposure. The presence of symptoms such as redness or itching indicates that your skin may be photosensitive. To avoid side effects, discontinue use and consult a dermatologist before using the product again.
- Before use, cleanse your face and ensure it is dry (makeup-free) to prevent any photosensitive ingredients in cosmetics from affecting the skincare effect.
- It is normal for your skin to appear slightly red after using the product. Typically, the redness subsides within an hour or two and your skin will return to normal. If you feel a burning sensation or any discomfort during the treatment, please stop using the product immediately.

Instructions:

How to Use:

- Step 1: Start by thoroughly cleansing your face and gently patting your skin dry.
- Step 2: Place the protective eye mask on the face, keeping the mask securely in position by following the "L" and "R" markings. Press and hold the power button on the remote control to turn on the facial mask.
- Step 3: The mask is available in four different modes: Daily Skin Care, Anti-Acne, Soothing, and Skin-Brightening. Choose the mode that suits your needs and preferences.
- Step 4: You can set the device to run for 10 minutes, 20 minutes, and 30 minutes. The timer button can be used to adjust the time. The device will automatically shut off once the timer is up. Remove the mask to end the treatment.

Choose your desired skincare mode and begin the treatment



Attach the protective eye masks onto the facial mask



After the treatment, remove the mask and proceed with your regular skincare routine




Wear the facial mask properly and switch

Warranty Terms and Conditions

Chinese Mainland

- Our company provides a 1-year warranty for customers who purchase this product within the Chinese Mainland. The warranty period starts from the date of receipt (for online purchases, it begins from the logistics receipt date, unless proven otherwise; whereas in physical transactions, the date of physical delivery is taken as the starting date.)
- Our company provides products and services in compliance with relevant laws and regulations such as the "E-Commerce Law of the People's Republic of China", "Product Quality Law of the People's Republic of China", and "Law of the People's Republic of China on the Protection of Consumer Rights and Interests". For offline purchases, if quality issues arise within 7 days, you can contact the seller with a valid proof of purchase or receipt to request a return or exchange; if quality issues arise within 15 days, you can contact the seller with a valid proof of purchase to request an exchange. For online purchases, you have 7 days from the delivery date to return the product without providing any reason, but it must be in sellable condition. Customers are responsible for paying the shipping charges for returning the product within 7 days, except for returns or exchanges due to quality issues.

Countries or regions outside Chinese Mainland

- If you purchased this product in a country or region outside the Chinese Mainland, the warranty period, return and exchange policies, and repair procedures will adhere to the laws and regulations of that specific country or region.
