





Device illustration LED Light Facial Mask






Operating procedure

1. Powering on and off and mode switching

• Connect both the controller and the mask port using the official cable provided

- To switch between the three modes, press and hold the controller's power button for 2s to power on, then press the power button: Anti-acne, soothing, and skin-brightening modes
- For each mode, the device will operate for 10 minutes before automatically turning off. Press and hold the power button for 2s to turn the device off in advance.



2. Charging the controller

- Only the controller needs to be charged individually because it supplies the electrical energy for the mask's lighting modules
- ullet Plug in a power adapter (one that supports a rated output \leqslant 10W and has a compliance certification like CQC) after connecting the Type-C charging cable to it

- When charging starts, the mode/power indicator starts flashing
- All 3 mode/power indicators are lit up when fully charged.
- 3. Checking the power status
- You can press or press and hold the controller to check the power status even if the mask is not connected
- You can use the controller switch/mode button to verify the power status while the mask is connected and powered off
- 1 indicator represents low power, while 3 indicators represent
- \bullet When only one indicator is left flashing rapidly 5 times before going off, the device has insufficient power and enters low battery protection, and shall be charged before using it again.



Care procedure

Step 1: Makeup removal and cleansing • Remove any makeup and cleanse your face before using the

device. You can then apply toner for basic moisturizing, but avoid using any products that include photosensitive or whitening



Step 2: Connecting the mask and the controller • Plug the officially provided cable into the controller and the mask

Step 3: Put on the mask and start the care mode

- Please select the mode that best suits your skin condition using the care recommendations. Different modes are suitable for different
- After the phototherapy care, applying a sheet facial mask will bring greater caring efficacy

[Anti-acne mode] Suitable for excessively-oily skin, and acne or pimple breakouts Care advice: Turn on the anti-acne mode after face cleansing and use a simple-ingredient moisturizing toner or lotion. If your skin still feels dry after using the device, apply more moisturizing products. Maintaining a healthy lifestyle is also helpful to lower the likelihood of acne recurrence (including exercise, a healthy diet, and enough sleep)



[Soothing mode]


Suitable for sensitive skin during seasonal changes, sunburn aftercare, healing from allergic reactions, or cosmetic surgery scars recovery Care advice: Set the device to soothing mode and use skin care products with gentle, non-irritating ingredients. [Skin-brightening mode]

Suitable for everyday skin-brightening or skin rejuvenation after staying up late

Care advice: Set the device to skin-brightening mode after face cleansing and makeup removal. To double the effect, use skin-brightening products after using the device. Before using the device, please avoid using any products containing vitamin C, retinol, or other photosensitive or irritating components



Step 4: Device maintenance

- After completing the care routine, you can place the device back in its storage box or pouch. If there are any smudges, wipe them off with a wet tissue or a soft, slightly damp cloth
