DIRECTIONS FOR NORMAL APPLICATION:

Dilute Foam Marker Concentrate™ 1.5 litre to 100 litres of water in the foam generator tank.

FOR EXTREME TEMPERATURE CONDITIONS (ABOVE 35°C)

Dilute Foam Marker Concentrate™ 2.5 litre to 100 litres of water in the foam generator tank. These ratios will produce a thick heavy foam which can be dropped in at intervals or 1 to 25 meters. Marker can be operated at speeds of 25km/hour with no adverse effects to foam quality.
