Section 4. First aid measures

Description of necessary first aid measures

Inhalation

: Remove victim to fresh air and keep at rest in a position comfortable for breathing. Section 7. Handling and storage

Precautions for safe handling

: Put on appropriate personal protective equipment (see Section 8). Eating, drinking and smoking should be prohibited in areas where this material is handled, stored and processed. Appropriate engineering controls

: Use only with adequate ventilation.
