DIRECTIONS FOR USE:

Soil Fit 8-0-3 Natural Base Fertilizer Fortified Soil Amendment is natural based and fortified for success. With an 8-0-3 analysis you'll get nutrition and greening, all while fortifying your soil with humic acid, stress reducing kelp extract and all important plant (wheat) protein hydrolysates, a natural source of amino acids (the building blocks of life).

Applications of Soil Fit can be made anytime of year as long as the turf is actively growing Water in with ¼" of irrigation or rainfall within 48 hours of application.

Do not apply near water, storm drains or drainage ditches. Do not apply if heavy rain is expected. Apply this product only to your lawn, and sweep any product that lands in the driveway. sidewalk. or street, back onto your lawn.

Application with rotary or pendulum spreaders is recommended for uniform distribution. The use of a drop spreader is not recommended. Consult your spreader manual or spreader manufacturer to determine spreader settings to achieve application rates desired. You may need to adjust the setting depending on the walking speed, spreader condition, and product.

DIRECTIONS FOR USE (Ornamentals):

For new landscape plantings, evenly apply up to 3 lbs. per 500 sq. ft. depending on cropp and soil analysis. Work into the soil to a depth of 6 inches. Once plants are established apply additional fertilizer based on County Extension Service recommendations. Apply fertilizer evenly and do not apply fertilizer directly to plant foliage or stems. Water in after application.

For shrubs, spread fertilizer evenly at a rate of up to 1.2 lbs. per 100 sq. ft. of bed area. The fertilizer should be kept away from the base of shrubs. Water in after application.

For trees (including palm), apply 1 lbs. of fertilizer per inch of trunk diameter at chest height (4" diameter tree = 4 lbs. of fertilizer) evenly under the canopy of the tree. An alternate method is to auger holes 6 to 8 inches deep in a grid pattern. Keep holes at least 3 ft. from the base of the tree. Place fertilizer in holes, evenly applying the appropriate amount of fertilizer under the canopy of the tree using 1 lbs. per inch of trunk diameter at chest height (a 4" diameter tree would require a total of 4 lbs. of fertilizer). Then finish filling the holes with dirt. Using either method, no more than 6 lbs. of fertilizer per application should be used per 1,000 sq. ft. of ground area. Water in after application.
