- Post a visible link to the BioShot website on your team's website. Ex. "yourairsoftteam.com"
- Hang banner and pass out BioShot merchandise (supplied by Bioshot) at all Airsoft events your team is involved in.
- Your team will not in any way resell BioShot bbs that are presented to you as a part of the sponsorship program.
- If your term is over and you/your team do not wish to continue with the Bioshot sponsorship you will be responsible for returning all Bioshot merchandise including team banners that may have been custom made by Bioshot.

Confidentiality.
