

ACOUSTICPLUS® SYSTEM



Mic./Tuner

Press to turn on tuner. Turn to control the mic level (system sensitivity). Try not set at maximum to avoid excessive resonance. Reduce level when high pitched noise or humming sound is heard.

Volume On/Off

Press and hold to turn on the AcousticPlus[®] system. Quick press to turn off. Turn to control the volume level.

Charging (Type-C)

Depending the power source, charging may take up to 6 hours. The battery lasts about 15 hours on acoustic-electric mode, 8 hours on AcousticPlus® mode.

Reverb - Room & Hall

Reverb Selection and intensity adjustment.

Left Half: Room audition mode. Right Half: Hall concert mode.

Effects - Chorus & Delay

Effect selection and intensity adjustment.

Left Half: Chorus effect adjustment. Right Half: Delay effect adjustment.

Light Indicator & Charging Port

GREEN: System ON


RED: System ON & Low Battery
OFF: System OFF / Dead Battery

Tips:

- 1. Try not to set all controls at maximum to avoid excessive resonance.
- 2. Save battery by turning off AcousticPlus® after playing.
- 3. Take battery out of planning to not play for a long time.

CHARGING

The X4 AcousticsPlus[®] guitar comes with an installed 18650 rechargeable battery. A 1/4 instrument cable male to USB charging cable is included. Connect the guitar to any USB power source like a phone charger to charge the AcousticPlus[®] system.
