Cell phone cases; Potpourri, powders, fragrancing sachets, liquid refills for air fresheners (non-cartridge systems), Reed diffusers; Liquid refills for air fresheners (cartridge systems); Shoe polishes; Deodorizers/Maskers not intended for skin contact (e.g. fabric drying machine deodorizers, carpet powders); Insecticides (mosquito coil, paper, electrical, for clothing) etc excluding aerosols; Scent delivery system using a dry air technology that releases a fragrance without sprays, aerosols or heated oils (technology of nubilization); Air freshening crystals; Toilet Blocks; Joss Sticks or Incense Sticks; Machine Dishwash Detergents and Deodorizers; Machine-only Laundry
