Liquid Soap, Bar Soap (toilet soap), Depilatory, Conditioner (rinse-off), Shampoos of all types (including baby shampoos). Face Cleansers of all types (washes, gels, scrubs, etc.). Shaving Creams of all types (stick, gels, foams, etc.). Body Washes of all types (including baby washes) and Shower Gels of all types Bath Gels, Foams, Mousses, Salts, Oils and other products added to bathwater

**CLASS 9B** 8.17%

Feminine hygiene pads/liners. Toilet paper. Wheat bags.

**CLASS 9C** 8.17%

Facial tissues, Napkins. Paper towels. Aerosols (including air fresheners sprays and air freshener pump sprays, but not including deodorant/antiperspirants, hair styling aids spray and animal sprays)

**CLASS 10A** 4.09%

Hand wash/Machine Wash Laundry Detergents of all types and bleach (liquid, powder, tablet, etc. including concentrates). Other Household Cleaning Products (fabric cleaners, soft surface cleaners, carpet cleaners etc.), Dry Cleaning Kits. Fabric Softeners of all types including softener sheets. Hand Dishwashing Detergent including concentrates. Hard Surface Cleaners of all types (bathroom and kitchen cleansers, furniture polish etc.), Shampoos for pets

**CLASS 10B** 4.09%  
Diapers, toilet seat wipes

**CLASS 11A** 100%

All non-skin contact. Air Fresheners and fragrancing of all types (concentrated aerosol air fresheners, plug-ins, solid substrate, membrane delivery, ambient, electrical) excluding aerosol products. Air delivery systems. Liquid refills for air fresheners (cartridge systems). Scent delivery system using a dry air technology that releases a fragrance without sprays, aerosols or heated oils (e.g. nebulization). Air freshening crystals. Joss Sticks, Incense. Toilet blocks. Insecticides (mosquito coil, paper, electrical, etc excluding aerosols); Machine only laundry detergent (e.g. liquid tabs). Plastic articles (excluding toys); Candles; Fuels; Paints.

**CLASS 11B** 100%

All incidental skin contact. Machine Dishwash Detergents and Deodorizers. Deodorizers/Maskers not intended for skin contact (e.g. fabric drying machine deodorizers, carpet powder). Potpourri, fragrancing sachets, liquid refills for air fresheners, etc. Reed Diffusers. Shoe polishes Animal Sprays (excluding aerosols); Treated Textiles; scented Distilled Water
