Children's toys

**CLASS 2 - limited to: 3.07%**

Deodorant and antiperspirant products of all types including any product with intended or reasonably foreseeable use on the axillae or labelled as such (spray, stick, roll-on, under-arm, deocologne, etc.)

---

**CLASS 3 - limited to: 2.22%**

Eye products of all types (eye shadow, mascara, eyeliner, eye make-up, eye masks, eye pillows, etc.) including eye care and moisturizer  
Facial make up and foundation  
Make-up remover for face and eyes  
Nose pore strips  
Wipes or refreshing tissues for face, neck, hands, body  
Body and face paint (for children and adults)  
Facial masks for face and around the eyes

---

**CLASS 4 - limited to: 28%**

Hydroalcoholic and non-hydroalcoholic fine fragrance of all types (Eau de Toilette, Parfum, Cologne, solid perfume, fragancing cream, aftershaves of all types, etc.)  
Fragranced bracelets  
Ingredients of perfume kits and fragrance mixtures for cosmetic kits  
Scent pads, foil packs  
Scent strips for hydroalcoholic products

**CLASS 5A - limited to: 14.67%**

Body creams, oils, lotions of all types

**CLASS 8 - limited to: 0.96%**

Intimate wipes

**CLASS 9 - limited to: 8.67%**

Bar soap  
 Shampoo of all type  
 Cleanser for face (rinse-off)  
 Conditioner (rinse-off)  
 Liquid soap / Body washes and shower gels of all types  
 Baby wash, bath, shampoo  
 Bath gels, foams, mousses, salts, oils and other products added to bathwater  
 Foot care products (feet are placed in a bath for soaking)  
 Shaving creams of all types (stick, gels, foams, etc.) / All depilatories (including facial) and waxes for mechanical hair removal  
 Shampoos for pets

## CLASS 10A - limited to: 8.67%

Hand wash laundry detergent (including concentrates)  
 Laundry pre-treatment of all types (e.g. paste, sprays, sticks)  
 Hand dishwashing detergent (including concentrates)  
 Hard surface cleaners of all types (bathroom and kitchen cleansers, furniture polish, etc.)  
 Machine laundry detergents with skin contact (e.g. liquids, powders) including concentrates  
 Dry cleaning kits  
 Toilet seat wipes  
 Fabric softeners of all types including fabric softener sheets  
 Household cleaning products, other types including fabric cleaners, soft surface cleaners, carpet cleaners, furniture polishes sprays and

Feminine hygiene conventional pads, liners, interlabial pads  
 Diapers (baby and adult) / Adult incontinence pant, pad

## CLASS 11B - limited to: 0.96%

Tights with moisturizers  
 Scented socks, gloves

Candles of all types (including encased)  
 Laundry detergents for machine wash with minimal skin contact (e.g. Liquid tabs, pods)  
 Automated air fresheners and fragrancing of all types (concentrated aerosol with metered doses (range 0.05-0.5mL/spray), plug-ins,  
 closed systems, solid substrate, membrane delivery, electrical, powders, fragrancing sachets, incense, liquid refills (cartridge), air  
 freshening crystals)  
 Air delivery systems  
 Cat litter  
 Cell phone cases  
 Deodorizers/maskers not intended for skin contact (e.g. fabric drying machine deodorizers, carpet powders)  
 Fuels  
 Insecticides (e.g. mosquito coil, paper, electrical, for clothing) excluding aerosols/sprays  
 Joss sticks or incense sticks  
 Dishwash detergent and deodorizers - f  
 Olfactive board games / Scratch and sniff / Scent pack  
 Paints  
 Plastic articles (excluding toys)  
 Scent delivery system (using dry air technology)  
 Shoe polishes  
 Rim blocks (Toilet)
