Candles; Air Fresheners and Fragrancing of all types (concentrated aerosol with metered doses (range 0.05-0.5ml/spray), plug-ins, solid substrate, membrane delivery, electrical; Air delivery Systems; Cell phone cases; Potpourri, powders, fragrancing sachets, liquid refills for air fresheners (non-cartridge systems), Reed diffusers; Liquid refills for air fresheners (cartridge systems); Shoe polishes; Deodorizers/Maskers not intended for skin contact (e.g. fabric drying machine deodorizers, carpet powders); Insecticides (mosquito coil, paper, electrical, for clothing) etc excluding aerosols; Scent delivery system using a dry air technology that releases a fragrance without sprays, aerosols or heated oils (technology of nubilization); Air freshening crystals; Toilet Blocks; Joss Sticks or Incense Sticks; Machine Dishwash Detergents and Deodorizers; Machine-only Laundry

Detergent (e.g. liquitabs); Plastic articles (excluding toys); Fuels; Fragranced lamp ring; Scratch and Sniff (sampling technology); Paints; Cat litter; Animal Sprays (all types); Treatment products for textiles (e.g. starch sprays, fabric treated with fragrances after wash, deodorizers for textiles or fabrics); Floor Wax; Odored Distilled Water (that can be added to steam irons)
