CLASS 2 2%

Deodorant and Antiperspirant Products of all types including any product with intended or reasonably foreseeable use on the axillae or labeled as such (spray, stick, roll-on, under-arm, deo-cologne and body spray, etc.);
Nose pore strips; Fragranced Bracelets

CLASS 3A 10%

Hydroalcoholic products applied to recently shaved skin (includes After Shave) (EdT range)

CLASS 3B 10%

Hydroalcoholic products applied to recently shaved skin (includes After Shave) (fine fragrance range)

CLASS 3C 10%

Eye Products of all types (eye shadow, mascara, eyeliner, eye make-up, etc) including eye care;
Men's Facial Creams and Balms; Baby creams, lotions, oils; Body Paint for Children

CLASS 3D 10%
Tampons

CLASS 4A 10%

Hydroalcoholic Products applied to unshaved skin (includes aqueous based, alcoholic based and hydroalcoholic) like Cologne, eau de cologne, Eau de Parfum or Parfum (EdT range); Ingredients of Perfume Kits;
Scent Pads; Foil Packs; Strips for Hydroalcoholic Products

CLASS 4B 10%

Hydroalcoholic Products applied to unshaved skin (includes aqueous based, alcoholic based and hydroalcoholic) like Cologne, eau de cologne, Eau de Parfum or Parfum (Fine Fragrance range).

CLASS 4C 10%

Hair Styling Aids Sprays of all types (pumps, aerosol sprays, etc.); Hair Deodorant; Body Creams, Oils, Lotions of all types (except baby creams, lotions, oils); Body sprays (including Body Mist) with no sonably foreseeable use on the axillae;
Body Paint (except those for children); Fragrance Compounds for Cosmetic Kits; Foot Care Products

CLASS 4D 10%

Fragrancing Cream; Solid perfumes

CLASS 5 10%

Women's Facial Creams/Facial Make-up; Facial Masks; Hand Cream; Hand sanitizers; Baby Powder & Talc; Hair permanent and other hair chemical treatments (e.g. relaxers) but not hair dyes; Dry Shampoo or Waterless Shampoo; Wipes or Refreshing Tissues for Face, Neck, Hands, Body

CLASS 6 *Not Available*

Mouthwash, including Breath Sprays; Toothpaste

CLASS 7A 4%
Intimate Wipes; Baby Wipes

CLASS 7B 4%
Insect Repellent (intended to be applied to the skin)

CLASS 8A (Maximum Pragmatic Level 2%) 10%
Make-up Removers of all types (not including face cleansers); Hair Styling Aids Non-Spray of all types (mousse, gels, leave-in conditioners etc.) ; Nail Care; Powders & talcs, all types (except baby powders and talcs)

CLASS 8B (Maximum Pragmatic Level 2%) 10%
Hair Dyes

CLASS 9A (Maximum Pragmatic Level 5%) 10%
Liquid Soap; Bar Soap (Toilet Soap); All Depilatories (including waxes for mechanical hair removal); Conditioner (Rinse-Off); Shampoos of all types (including baby shampoos); Face Cleansers of all types (washes, gels, scrubs, etc.); Shaving Creams of all types (stick, gels, foams, etc.); Body Washes of all types (including baby washes) and Shower Gels of all types; Bath Gels, Foams, Mousses, Salts, Oils and Other Products added to bathwater

CLASS 9B (Maximum Pragmatic Level 5%) 10%
Feminine hygiene - pads, liners; Toilet paper; Wheat bags

CLASS 9C (Maximum Pragmatic Level 5%) 10%
Facial tissues; Napkins; Paper towels; Other Aerosols (including air freshener sprays and air freshener pump sprays, but not including deodorants/antiperspirants, hair styling aids sprays);
Fragranced Face Masks (or surgical masks)

CLASS 10A (Maximum Pragmatic Level 2.5%) 10%
Handwash Laundry Detergents of all types including concentrates; Machine Wash Laundry Detergents (liquids, powders, tablets, etc.) including laundry bleach and concentrates; Hand Dishwashing Detergent including concentrates; Hard Surface Cleaners of all types (bathroom and kitchen cleansers, furniture polish etc.); Household Cleaning Products, Other Types (fabric cleaners, soft surface cleaners, carpet cleaners etc.); Dry cleaning kits; Fabric Softeners of all types including fabric softener sheets; Scented gloves, socks, tights with moisturizers; Shampoos for pets

CLASS 10B (Maximum Pragmatic Level 2.5%) 10%
Diapers; toilet seat wipes

CLASS 11 100%

All non-skin contact or incidental skin contact including:

Candles; Air Fresheners and Fragrancing of all types (concentrated aerosol with metered doses (range 0.05-0.5ml/spray), plug-ins, solid substrate, membrane delivery, electrical; Air delivery Systems; Cell phone cases; Potpourri, powders, fragrancing sachets, liquid refills for air fresheners (non-cartridge systems), Reed diffusers; Liquid refills for air fresheners (cartridge systems); Shoe polishes; Deodorizers/Maskers not intended for skin contact (e.g. fabric drying machine deodorizers, carpet powders); Insecticides (mosquito coil, paper, electrical, for clothing) etc excluding aerosols; Scent delivery system using a dry air technology that releases a fragrance without sprays, aerosols or heated oils (technology of nubilization); Air freshening crystals; Toilet Blocks; Joss Sticks or Incense Sticks; Machine Dishwash Detergents and Deodorizers; Machine-only Laundry

Detergent (e.g. liquid tabs); Plastic articles (excluding toys); Fuels; Fragranced lamp ring; Scratch and Sniff (sampling technology); Paints; Cat litter; Animal Sprays (all types); Treatment products for textiles (e.g. starch sprays, fabric treated with fragrances after wash, deodorizers for textiles or fabrics); Floor Wax; Odored Distilled Water (that can be added to steam irons)
