### CLASS 1 - Contact us

Lip products of all types (solid and liquid lipsticks, balms, clear or colored, etc.)  
Children's toys

### CLASS 2 - limited to : 4.58%

Deodorant and antiperspirant products of all types including any product with intended or reasonably foreseeable use on the axillae or labelled as such (spray, stick, roll-on, under-arm, deocologne, etc.)

### CLASS 3 - limited to : 2.08%

Eye products of all types (eye shadow, mascara, eyeliner, eye make-up, eye masks, eye pillows, etc.) including eye care and moisturizer  
Facial make up and foundation  
Make-up remover for face and eyes  
Nose pore strips  
Wipes or refreshing tissues for face, neck, hands, body  
Body and face paint (for children and adults)  
Facial masks for face and around the eyes

### CLASS 4 - limited to : 72.92%

Hydroalcoholic and non-hydroalcoholic fine fragrance of all types (Eau de Toilette, Parfum, Cologne, solid perfume, fragancing cream, aftershaves of all types, etc.)  
Fragranced bracelets  
Ingredients of perfume kits and fragrance mixtures for cosmetic kits  
Scent pads, foil packs  
Scent strips for hydroalcoholic products

### CLASS 5A - limited to : 3.13%

Body creams, oils, lotions of all types

Foot care products (creams and powders)  
Insect repellent (intended to be applied to the skin)  
All powders and talc (excluding baby powders and talc)

### **CLASS 5B - limited to : 2.6%**

Facial toner  
Facial moisturizers and creams

### **CLASS 5C - limited to : 2.6%**

Hand cream  
Nail care products including cuticle creams, etc.  
Hand sanitizers

---

### **CLASS 5D - limited to : 0.89%**

Baby cream/lotion, baby oil, baby powders and talc

### **CLASS 6 - Contact us**

Toothpaste  
Mouthwash, including breath sprays  
Toothpowder, strips, mouthwash tablets

### **CLASS 7A - limited to : 2.08%**

Rinse-off hair permanent or other hair chemical treatments (e.g. relaxers), excluding hair dyes

---

### **CLASS 7B - limited to : 2.08%**

Hair sprays of all types (pumps, aerosol sprays, etc.)  
Hair styling aids non sprays (mousse, gels, leave-on conditioners)  
Hair permanent or other hair chemical treatments (leave-on) (e.g. relaxers), including leave-on hair dyes  
Shampoo - Dry (waterless shampoo)  
Hair deodorizer

### **CLASS 8 - limited to : 0.89%**

Intimate wipes  
Tampons  
Baby wipes  
Toilet paper (wet)

---

### **CLASS 9 - limited to : 5.21%**

Bar soap  
Shampoo of all type  
Cleanser for face (rinse-off)  
Conditioner (rinse-off)  
Liquid soap  
Body washes and shower gels of all types  
Baby wash, bath, shampoo  
Bath gels, foams, mousses, salts, oils and other products added to bathwater  
Foot care products (feet are placed in a bath for soaking)  
Shaving creams of all types (stick, gels, foams, etc.)  
All depilatories (including facial) and waxes for mechanical hair removal  
Shampoos for pets

### **CLASS 10A - limited to : 5.21%**

Hand wash laundry detergent (including concentrates)  
Laundry pre-treatment of all types (e.g. paste, sprays, sticks)  
Hand dishwashing detergent (including concentrates)  
Hard surface cleaners of all types (bathroom and kitchen cleansers, furniture polish, etc.)  
Machine laundry detergents with skin contact (e.g. liquids, powders) including concentrates  
Dry cleaning kits  
Toilet seat wipes  
Fabric softeners of all types including fabric softener sheets  
Household cleaning products, other types including fabric cleaners, soft surface cleaners, carpet cleaners, furniture polishes sprays and wipes, leather cleaning wipes, stain removers,  
fabric enhancing sprays, treatment products for textiles (e.g. starch sprays, fabric treated with fragrances after wash, deodorizers for textiles or fabrics)  
Floor wax  
Fragranced oil for lamp ring, reed diffusers, pot-pourri, liquid refills for air fresheners (non-cartridge systems), etc.  
Ironing water (Odorized distilled water)

### **CLASS 10B - limited to : 32.81%**

Animal sprays – sprays applied to animals of all types  
Air freshener sprays, manual, including aerosol and pump  
Aerosol/spray insecticides

---

### **CLASS 11A - limited to : 0.89%**

Feminine hygiene conventional pads, liners, interlabial pads  
Diapers (baby and adult)  
Adult incontinence pant, pad

---

### **CLASS 11B - limited to : 0.89%**

Tights with moisturizers  
Scented socks, gloves  
Facial tissues (dry tissues)  
Napkins/Paper towels  
Wheat bags  
Facial masks (paper/protective) e.g. surgical masks not used as medical device  
Fertilizers, solid (pellet or powder)

---

### **CLASS 12 - 100%**

Candles of all types (including encased)  
Laundry detergents for machine wash with minimal skin contact (e.g. Liquid tabs, pods)  
Automated air fresheners and fragrancing of all types (concentrated aerosol with metered doses (range 0.05-0.5mL/spray), plug-ins, closed systems, solid substrate, membrane delivery, electrical, powders, fragrancing sachets, incense, liquid refills (cartridge), air freshening crystals)  
Air delivery systems  
Cat litter  
Cell phone cases  
Deodorizers/maskers not intended for skin contact (e.g. fabric drying machine deodorizers, carpet powders)  
Fuels  
Insecticides (e.g. mosquito coil, paper, electrical, for clothing) excluding aerosols/sprays  
Joss sticks or incense sticks  
Dishwash detergent and deodorizers – for machine wash  
Olfactive board games
