**APPEARANCE:** 

Sprinkles sugar sand are very small pieces of edible confectionery used as a decoration or to add texture to desserts such as brownies, cupcakes, doughnuts or ice cream. The tiny candies are produced in a variety of colors and are generally used as a topping or a decorative element.

**STABILITY** 

Store in tightly sealed containers in a cool, dry, dark place

When stored under the proper conditions, initial product strength and color hue should be maintained

**SHELF LIFE** 

Minimum of 24 months from date of manufacture




