Initial Order Minimum USD \$5,000 and Full Pallets for Re-Orders
Minimum order quantities are full master cartons per product scent and full layers per product type based on the International customer order sheet.

International Distributor Requirements:

Initial Order Minimum USD \$15,000 and Full Pallets for Re-Orders
Minimum order quantities are full layers per product type based on the distributor order sheet.

The order sheets will be provided upon initial approval of customer application.

AGREEMENTS & REQUIREMENTS IF APPROVED:

By ordering from The Candleberry Co., you confirm that you are NOT a business being conducted out of a residence or out of a third party venue or website ("booth" sales, Etsy, Ebay, Amazon). You will not sell Candleberry products on or through such third party sites, unless approved, in writing, by Candleberry, in advance.

All Candleberry approved customers MUST keep a valid, active email address on file, with Candleberry, at all times, without opting out. Your email address will be used for communications about account invoices, charges, needs, upcoming events and any other information Candleberry deems beneficial and/or vital to the account. Opting out of these emails will cause your account to move to "deactivated" status.

SALES & PROMOTIONS

POS - All printed and digital materials not created by Candleberry must be pre-approved by Candleberry.

Candleberry offers its retail customers a "Candle of the Month" at a 20% discount. We encourage our partners to also offer a "Candle of the Month". You may also have one sale per month, for up to five consecutive days, for discounts of up to 30%. Alternatively, you may run a "Buy 2, get 1 free" program that coincides with that five consecutive day period each month. We support extended discounting only of discontinued, out of season and aged or damaged products. If you intend to sell aged or damaged products at a discounted rate, you must first provide pictures of such products to Candleberry, for extended discounting approval.
