TEMPLATE LETTER

Dear Insert Elected Official's Name,

I'm a breast cancer survivor and mother advocating for insurance equality. Right now, new parents in the U.S. can get a free breast pump and lactation support through the Affordable Care Act, but no coverage for formula or donor milk. Insurance coverage is tied solely to the health of the baby, not the physical capabilities of a mother to be able breastfeed. Coverage for formula or donor milk is only considered if the baby has a diagnosed medical condition. But in cases where the mom physically cannot breastfeed due to a mastectomy or breast cancer, the medical necessity for formula or donor milk still exists-- yet a policy to support them does not.

TEMPLATE PHONE CALL

WHO

Identify yourself and explain your relationship with the senator or representative. "Hello, this is NAME, I'm a constituent of the INSERT Member of Congress and have lived in NAME TOWN for x years."

WHY

Explain why you are calling: your personal story and why this issue is important. I'm calling as a breast cancer survivor and mother advocating for insurance equality.
