



Competition Suit Rental Agreement

This Suit Rental Agreement (“Agreement”) is between (“Athlete”) and OMG Bikinis.

OMG Bikinis provides a suit rental for one (1) competition with free return shipping and free post show sterilizing.

General Rules

Athletes’ suit will be sent via USPS Priority with signature required. OMG Bikinis will ship Athletes’ suit ten days before the show date to ensure that Athlete receives it on time. The suit must be received back in OMG Bikinis facility within 5 days of the completion of the show. 5-th day after Athletes’ show day is a due date. There is a \$20 per day late fee for any suit that is sent back after the 5-day window. If Athletes’ show date changes and Athlete needs to adjust rental date, Athlete must contact OMG Bikinis ASAP to guarantee that the suit is available for a new date. If Athlete decides to no longer compete and OMG Bikinis held a reserved suit for more than 30 -days period total, Athletes’ rental fee will be returned to Athlete in the form of store credit.

Rental Specifics

Each suit available for rent is described in detail on the listing. It is Athlete’ responsibility to go through the sizing and measurement information before placing an order. Athlete receives rented suit with a list of instructions and recommendations how to ensure the best fit. Once the rental suit is received Athlete has to let OMG Bikinis know immediately if there’s any problems. Athlete is not allowed to make any

permanent alterations on the suit, as it's considered irreparable damage and requires a full cost of the suit to be paid. If rented suit just does not fit whatsoever, Athlete must return it to OMG Bikinis facility immediately using the same package and return shipping label included in the package. In this case Athlete will be provided a store credit that can be used towards the purchase of a new competition suit or renting of another suit.

Care and Cleaning

Athlete agrees to the following:

Do not keep the rental in any moist or hot places, like bathroom.

Do not use bikini glue to keep your suit in place. Bikini glue is impossible to take off the suit, it's considered irreparable damage, and Athlete will be responsible for a full cost of the suit. Athlete can use 2way tape.

Athlete is responsible for cleaning the suit before returning it.

DO NOT machine wash, DO NOT dry clean, DO NOT soak for a long time or bleach, DO NOT scrub or twist.

Suits must be hand washed within a few hours after the show. Soak the suit in lukewarm water and gently scrub from inside with mild detergents. Rinse is repeatedly until water run clear. Hang it dry. If a suit isn't properly cleaned before being returned, Athlete will be charged \$50 cleaning fee. All suits are sterilized as they return to the facility. Suit has to be sent back dry.

Damage

If a suit is returned in a damaged, but in repairable state, a \$50 damage fee will be charged to Athlete's credit card. If a suit is returned and is damaged beyond repair, Athlete will be contacted and charged for damages up to the remaining balance of the suit.

Return

Athlete must send the cleaned and dry suit back via USPS, in the original packaging, using the paid return label that OMG Bikinis provides. This must be done no later than 5 days after the show date as it is on the contract. If you Athlete decides to use another company to ship the package and it gets lost, Athlete will be responsible for the full cost of the suit. Once the suit

arrives to OMG Bikinis facility, OMG Bikinis inspects it and reaches out to Athlete to confirm the arrival, suit condition and additional charges that may occur.

Fees Athlete acknowledges and agrees to the following fees:

Late Rental Return Fee = \$20 per day _____ (initial)

Non-return Fee = full retail cost of the suit _____ (initial)

Repairable damage Fee = \$50 _____ (initial)

Irreparable damage = full retail cost of the suit _____ (initial)

Cleaning fee if suit is not cleaned properly = \$50 _____ (initial)
