TERMS & CONDITIONS

BOOKINGS

- » McLaren Vale Distillery does not take tentative bookings
- » A non-refundable deposit of \$1,000 is required to secure your booking
- » A minimum spend of \$7,000 is required on beverage package

PRICING

- » All prices are current at the time of quotation and are subject to change
- » All prices are GST inclusive
- » All quoted prices are for a 5pm guest arrival and 5.30pm ceremony, followed by a 6pm reception
- » Additional fees will be incurred for earlier ceremony or to close the venue for the day
- » Public Holidays will incur a 20% surcharge for beverage packages and take into account higher wages

PAYMENT PLAN

- » The non-refundable deposit of \$1,000 is required to secure your booking, and will be deducted from your venue hire
- » The balance of venue hire is due 6 months prior.
- » 50% of your beverage package is to be paid 3 months prior to your wedding date
- » 50% of your beverage package is to be paid 3 weeks prior to your wedding date

VENDORS

- » All vendors must send through a copy of public liability insurance
- » Vendor information form to be filled in and sent to wedding coordinator 60 days prior to the wedding day

- » Vendors must be informed they are required to have a site visit with wedding coordinator 30 days prior to the wedding day

ALCOHOL

- » The service of alcohol will cease at 11pm
- » We take responsible service of alcohol seriously, and will not supply liquor to persons under 18 years of age or guests showing signs of intoxication
- » Intoxicated guests will be asked to leave the premises
- » If guests display unsafe or threatening behaviour police will be called

DAMAGES AND THEFT

- » Clients are responsible for any damages to the property or equipment caused by guests whether accidental or otherwise
- » A fee may be charged for excessive glassware breakages or additional cleaning due to disorderly behaviour
- » Fines will be enforced if guests steal alcohol and/or other items

LIABILITY

- » McLaren Vale Distillery will not be liable for any loss, injury, theft or damage to personal goods brought to the venue by clients or guests/vendors of the clients

ADDITIONAL TERMS

- » Guests are permitted to leave the premises no later than 11.30pm and this must be communicated to transport companies and guests
- » If guests are still onsite past 11.30pm additional fees may be charged to cover staff time

- » Clients must remove all personal items prior to 11am the following day as we operate service
- » All vendors organised by the client must adhere to any and all bump in /bump out requirements
- » Sparklers are only permitted if it is a total non-fire ban day
- » Only natural rose petals or leaves can be used as confetti

EMERGENCY CLAUSE

- » In the event of a bushfire threat, bushfire or other case of natural disaster, McLaren Vale distillery may close the venue to ensure patron, staff and community safety
- » In the unlikely event of venue closure, following consultation with emergency services, McLaren Vale Distillery will notify you as early as possible and refund the full amount paid
