



Summa Cutter* Warranty:

Summa America warrants its cutting roll-plotters against defects in parts for a period of two (2) years from date of purchase. Consumables, accessories (mentioned in the "Consumables and Accessories" - pricelist) are excluded from this warranty.

This warranty is made only to the original authorized Summa America Cutter partner (The "Partner").

This warranty applies only to new equipment purchased in USA. All replacement parts are warranted for a period of ninety (90) days from date of invoice, regardless of when the parts are eventually installed.

This warranty is void if the product has been damaged by accident, abuse, misuse, negligence or misapplication, or has been modified or repaired by others without the written permission of Summa America. This warranty is also void when the maintenance procedures, described in the user's manual, are neglected or not carried out correctly.

If you discover physical defects on consumables or accessories (mentioned in the "Cutter - Consumables and Accessories" - pricelist), Summa America will replace the defective material at no charge, provided you return the item to be replaced within 30 days after purchase date.

Returning of any defective material should be done in accordance with Summa America's RMA procedures (Return Material Authorization). This warranty will be void if the RMA procedures are neglected or not carried out correctly. These procedures can be obtained from Summa America's service department by simple request.

Notwithstanding the above limitations and warranties, Summa America's liability hereunder for damages incurred by the partner or others shall not exceed the amount paid by the partner for the particular product involved.

No action arising of any claimed breach of this warranty or transactions under this warranty may be brought more than one (1) year after the cause of action has accrued, or more than three (3) years after the date of the Summa America sales document for the product, whichever first occurs.

Summa America reserves the right to make changes to the product without notice. In no event will Summa America be liable for direct, indirect, special incidental, or consequential damages resulting from any breach of warranty or under any legal theory, even if advised of the possibility of such damages.

The warranty and representations set forth above are exclusive and in lieu of all others, express or implied, in fact or in law.



The warranty is part of, and is subject to law of, business to business sales.

Any dispute, controversy or claim arising out of or relating to this warranty or validity thereof shall be finally settled by arbitration in accordance with the Rules of arbitration of the Chamber of Commerce and Industry in Bruges, Belgium. The arbitration shall consist of one arbitrator and the arbitration shall be in Dutch or English language, in Bruges, Belgium

Some states and countries do not allow the exclusion of limitation of implied warranties of liability or incidental or consequential damages, so the limitation or exclusion may not apply to you. This warranty gives you specific legal rights, and you may also have other rights which vary from state to state or country to country.
