Rental Terms & Conditions

Title

Title to the items shall remain at all times with the LM Treasures. No title or right to The Items shall pass to Customer, except the right herein expressly granted. Customers are not permitted to mold or in any way physically replicate any item. Customers shall give LM Treasures immediate notice in the event that any of the items are levied upon or are about to become threatened with seizure, and Customer shall indemnify LM Treasures against all loss and damage caused by such action.

Rental Period

The rental period shall cover all time consumed in transporting the items, including the date on which LM Treasures delivers or picks up physical possession of the items. LM Treasures acknowledge that Customer is responsible and liable for the items from the time it leaves LM Treasures place of business until the items are returned to and accepted by LM Treasures.

Release of liability

Customer shall be solely liable for all claims, including but not limited to claims for personal injury or damage to property, arising, directly or indirectly, in connection with the Items. Customer agrees to pay the retail price or the "Replacement Value" of any Items that are damaged as a result to the rental. Customer hereby accepts all risks of loss, theft, damage, destruction, or other injury to the items from any and every cause whatsoever. No such loss or damage shall impair any obligation of Customer hereunder, which shall continue in full force and effect. In the event of damage to or loss of the Items which are returned to LM Treasures no later than (21) days following the scheduled return date, Customer shall pay the Replacement Value plus any rental payments.

Maintenance and Alterations

Customer shall keep the items in good and working condition and shall only use the items for their intended purpose. Customer shall not change, modify, or alter the items without LM Treasures prior written consent. Customer shall be billed for any damages in the event that such items are not returned in good condition. Customer shall see that the items are not subject to repair and not subject to careless or unnecessarily rough usage.

Inspection

Customer shall inspect the items and acknowledge that items are in good condition. Unless Customer gives notice to LM Treasures, specifying any imperfection or other damages to the items prior to the usage of items then the Customer is agreeing that all items have been fully inspected and acknowledged that the items are in good condition.

Warranties

Company makes no warranties, express or implied, as to any matter whatsoever, including, without limitation, the condition of the items, their merchantability should be returned in same condition as received.
