Form 990, Part VI, Section B, Line 11b - The Treasurer prepares the Form 990. The President reviews it and all required schedules in detail. All members of the board are mailed copies of the submission for review at least 1 week prior to filing.

Form 990, Part VI, Section B, Line 12c - The organization's Conflict of Interest Policy applies to all member of the Board of Directors, who are required annually to sign that they have reviewed and understand the policy. Should a potential conflict arise, the specific board member must recuse themselves from all deliberations and decisions pertaining to the matter.

Form 990, Part VI, Section C, Line 19 - The organization's web site contains an ABOUT US page on which the Mission Statement, Articles of Incorporation, Bylaws, OCI Policy and the most recent IRS 990 filing documents are posted.

Form 990, Part XI, Line 9 - Changes in net assets: Change in real estate value +\$6,100; change in investments -\$1,607; change in pool furnishings +\$1,475
