

**GAMERS HERO GIVEAWAY #1 (ULTIMATE GAMING GIVEAWAY)  
OFFICIAL RULES  
NO PURCHASE NECESSARY. PURCHASE OR ACCEPTANCE OF  
A PRODUCT OFFER WILL NOT IMPROVE YOUR CHANCES OF WINNING**

1. **ELIGIBILITY:** The Gamers Hero Giveaway #1 (the "Giveaway") is open only to legal residents of the 50 United States and the District of Columbia who are 18 years of age or older (or legal age of majority in the state in which they reside). Employees of Gamers Hero, its affiliates, subsidiaries, advertising, promotion partners and internet agencies (collectively "Released Parties") and their immediate family members (spouse, parent, child, sibling, grandparent) and/or those living in the same household of each are not eligible. The number of entries you receive will be based on the list price of your eligible purchase (excludes sales tax and shipping charges) and will be rounded down to the nearest dollar. If a purchase is returned prior to the Giveaway drawing, entry will be voided. Your purchase transaction must be received by 11:59:59 PM CT January 13, 2019 to be eligible to receive entries.
  - b) Mail-in Entry: To enter without making a purchase, on a plain piece of 3"x5" paper (or postcard), hand print your first and last name, street address, city, state/province, zip/postal code, date of birth (mm/dd/yyyy), e-mail address, and daytime telephone number including area code. Then, in 20 words or more, hand write why you want to win the Giveaway.
