John Fea's Was America Founded as a Christian Nation? A Historical Introduction* (2011) is published by Westminster/ John Knox Press. Ross Douthat's Bad Religion: How We Became a Nation of Heretics* (2012) is published by Free Press. John Fea is also the author of *The Way of Improvement Leads Home*: Philip Vickers Fithian and the Rural Enlightenment in Early America* (University of Pennsylvania Press, 2008). Fea was (with Jay Green and Eric Miller) the co-editor of *Confessing History*: Explorations in Christian Faith and the Historian's Vocation* (Notre Dame, 2010). This volume contains essays by each of the editors (listeners may remember Eric Miller from volumes 77 and 103 as the biographer of Christopher Lasch), as well as by Thomas Albert Howard ("Virtue Ethics and Historical Inquiry: The Case of Prudence"), Mark R. Schwehn ("Faith Seeking Historical Understanding"), Christopher Shannon ("After Monographs: A Critique of Christian Scholarship as Professional Practice"), Lendol Calder ("For Teachers to Live, Professors Must Die: A Sermon on the Mount"), and Wilfred M. McClay ("The Christian Historian and the Idea of Progress").
