Politics and the Kingdom of God

James W. Skillen's The Good of Politics: A Biblical, Historical, and Contemporary Introduction* (2014) is published by Baker Academic. See also Skillen's In Pursuit of Justice: Christian-Democratic Explorations* (Rowman & Littlefield, 2004). Skillen's thinking about the nature of government is influenced by the work of the Dutch neo-Calvinist philosopher Herman Dooyeweerd. For a detailed study of Dooyeweerd's ideas, see Jonathan Chaplin's Herman Dooyeweerd: Christian Philosopher of State and Civil Society* (University of Notre Dame Press, 2011). Chaplin and Skillen's former colleague Stanley Carlson-Thies both contributed to the anthology Christianity and Civil Society: Catholic and Neo-Calvinist Perspectives* (Lexington, 2008), a collection that also includes essays by Jean Bethke-Elshtain, Russell Hittinger, and others. David Kovzis's book, Political Visions & Illusions: A Survey & Christian Critique of Contemporary Ideologies* (IVP Academic, 2003) is also in general sympathy with Skillen's views. From Irenaeus to Grotius: A Sourcebook in Christian Political Thought, 100-1625* (Eerdmans, 1999), edited by Oliver O'Donovan and Joan Lockwood O'Donovan, is an important volume illustrating the development (which is not necessarily to say the progress) of Christian thinking about political life. See also their collection of essays in Bonds of Imperfection: Christian Politics, Past and Present* (Eerdmans, 2004). See also Oliver O'Donovan's, The Desire of the Nations: Rediscovering the Roots of Political Theology* (Cambridge University Press, 1996) and The Ways of Judgment* (Eerdmans, 2005). Joan Lockwood O'Donovan is also the author of Theology of Law and Authority in the English Reformation (Scholar's Press, 1991). James Skillen was a contributor to an anthology that examines Oliver O'Donovan's work: A Royal Priesthood? The Use of the Bible Ethically and Politically* (Zondervan, 2002), edited by Craig G. Bartholomew. The Blackwell Companion to Political Theology* (Wiley-Blackwell, 2006), edited by Peter Scott and William T. Cavanaugh, contains essays about a wide range of issues related to a theological understanding of politics, including Trinity, Creation, Christology, ecclesiology, and eschatology. Contributors include Stanley Hauerwas, Daniel M. Bell, Jr., Catherine Pickstock, and Robert W. Jenson. Other titles of possible interest include: William T.
