



## Consumer Product Announcement

April 17, 2019

Blissco has identified one labelling inaccuracy on two premium cannabis, double pre-roll packages, and is voluntarily recalling the affected products. The original labels displayed the THC / Total THC content for both pre-roll units combined and not by the single pre-roll unit. All other information displayed on label is accurate and the consumption of the affected products does not pose any risk to the safety of consumers.

### Consumer Alert:

Type III Voluntary recall of Blissco dried cannabis pre-roll 2 x 0.5 g, Lot 1905001.

### Identified:

To date, Health Canada and Blissco have not received any product complaints for the affected lot numbers. The issue identified is that one label field from the original products were labelled with incorrect variable data.

### Time Period / Number of Units:

Between March 29, 2019 – April 15, 2019, 754 units were distributed to Cannabis retailers in BC.
