Wholesale Program Terms & Policies

By becoming a Shakti Mats Wholesale partner, you agree with the terms and policies in the agreement ("Agreement") below. Please read the entire Agreement. It is a legal agreement between you and Team Shakti Distribution. By submitting the online application, you agree that you have read and understood this Agreement, and that, if Team Shakti Distribution accepts your application, you agree to be legally responsible for each term and policy.

This Agreement begins when Team Shakti Distribution accepts you as a wholesaler and will end when your participation is terminated by either party.

Team Shakti Distribution may change this Agreement at any time. If any change is unacceptable to you, you are entitled to terminate your participation. Your continuing participation as a wholesaler will constitute your acceptance of any change. It is your responsibility to keep up to date with any changes made to the Agreement.

You or Team Shakti Distribution may suspend or terminate your participation as a wholesaler at any time for any reason.

Team Shakti Distribution reserves the right to change the price of their wholesale or retail products at any time.

Online Advertising Policy

You shall not purchase keywords, domain names or any other identifiers that include the words "Shakti" or "Shakti Mats" or any variations or misspellings thereof on third party websites or platforms not owned by yourself.

Specifically, this policy prohibits you from:

- 1) Bidding on "Shakti Mats", "Shakti", and any similar keyword strings for advertisements on search engines (e.g. Google, Bing) and marketplaces (e.g. Amazon),
- 2) Listing our range on marketplaces such as Amazon, And
- 3) Purchasing domain names based on "Shakti" or variations

Assets

Team Shakti Distribution grants to you a non-exclusive, non-transferable license ("License") to use Retailer Assets as specified under the terms and policies of this Agreement. The term of the License shall expire upon your departure as a wholesaler or termination of this Agreement.

You will use the Assets as Team Shakti Distribution instructs:

- 1) You will not alter, add to, subtract from, or otherwise modify the Assets as Team Shakti Distribution provides them unless you obtain prior written consent from Team Shakti Distribution.
- 2) You may only use the Assets for the purpose of promoting Team Shakti Distribution and its products.
- 3) Team Shakti Distribution retains all rights, ownership, and interest in the Assets, and in any copyright, trademark, or other intellectual property in the Assets. Nothing in this Agreement shall be construed to grant you any rights, ownership, or interest in the Assets, or in the underlying intellectual property, other than the License to use Assets as granted in this Agreement.
- 4) You will not make any claim to ownership of the Assets, or of the copyright, trademark, or other intellectual property therein.
- 5) You will not publish or otherwise distribute any other advertising materials that reference Team Shakti Distribution unless Team Shakti Distribution gives prior written consent to the distribution of such materials.

Prohibited Claims
