## Madison Mouthguard Fitting Instructions:

1. Insert mouthguard into your mouth to test the size and comfort.
2. If mouthguard is too long trim the length equally on both sides.
3. Insert the mouthguard back into your mouth to practice forming the mouthguard, while biting it gently and pushing your fingers over the lips.
4. Pour boiling water into a big bowl or mug.
5. Allow boiling water to cool for 2 minutes before submerging the mouthguard into the water.
6. **M1 Mouthguards**  
Submerge in water for 45 seconds.
7. **Magnum Pro, Mission, M2 & Supporter Mouthguards**  
Submerge in water for 60 seconds.
7. Remove the mouthguard from water with a fork or spoon and shake off the excess water from the mouthguard.
8. Position the mouthguard on your upper teeth arc and bite down hard at the same time while pushing your tongue firmly against the roof of your mouth and sucking it hard for 30 seconds to gain the ultimate fit. At the same time, massage around your lips firmly.
9. Remove the “Firmly Fitted” mouthguard from your mouth, rinse it with cold water.
10. You can repeat steps 4 to 8 of the process if you feel a better fit is required.

## Care Instructions:

After use it is recommended you wash the mouthguard in clean water only and always store your mouthguard in the case provided.

Never leave your mouthguard in the sun or hot areas otherwise it will deform because of the heat.

For maximum protection replace your mouthguard after every season, especially at a junior level.

**All models, both junior and senior are not suitable to be used with orthodontic bands.**

## WARNING

*Madison Mouthguards have been designed for maximum protection and will not stop accidents from happening to your mouth. It's highly recommended that you check the mouthguard for damage or faulty workmanship before you use this product. Always wear your mouthguard to training or practice sessions as that is where most injuries occur.*

## LIMITED DENTAL WARRANTY

### 1. Warranty

Madison Sport PTY LTD (ACN: 065 317 160) warrants this mouthguard free from defects in material or workmanship that could cause damage, loss, or injury to the sound natural teeth of the user when used properly in the supervised athletic contest or coach supervised training session. This warranty is personal to the user who originally purchased the mouthguard and is valid for 1 year from the date of purchase.

### 2. Limitation of Liability

Madison Sport's liability under this warranty is limited to the lesser value of:

- (a) The actual dental expenses incurred by the user; and
- (b) The amount for each listed mouthguard model stated as follows:

To make a claim under this warranty the user must notify Madison Sport PTY LTD in writing within 30 days of the alleged damage, loss or injury occurring.

- (a) A statement from the user setting out the time, date and place at which the alleged damage, loss or injury occurred;

- (b) Proof of purchase by the user of the mouthguard, including evidence of the actual date of purchase and the particular store or outlet from which the mouthguard was purchased;
- (c) A statement from a participating official or supervising coach, instructors or teacher; stating that the mouthguard was being used properly and in accordance with all applicable instructions at the time of the alleged damage, loss or injury;
- (d) A statement from a licensed dentist who provided the necessary treatment to the user as to the cause of the alleged damage, loss or injury and including an opinion whether in his or her view the loss, injury was attributable to a defect in the material or workmanship of the mouthguard

(such treatment to have been provided within 15 days of the alleged damage, loss or injury);

- (a) If applicable, a statement from the user whether that user has made or is otherwise entitled to make a claim under applicable insurance or under any statutory or other compensation scheme; and

- (b) The original mouthguard so that Madison Sport PTY LTD has an opportunity to inspect and access any actual or alleged defect in the mouthguard.

All notifications, statements and supporting evidence including the alleged defective mouthguard must be sent to Madison Sport PTY LTD marked for the attention of claims section, Madison Sport PTY LTD, PO.Box 133, Northgate. QLD 4013 AUS.

### 4. Exceptions

This warranty does not apply:

- (a) in respect of any damage, loss or injury due to or arising from:
  - (i) the failure of the user to follow any published instructions for use (including the fitting, storage and handling of the mouthguard) provided by Madison Sport PTY LTD with warranty or in any subsequent notice;
  - (ii) the reuse of a damaged or defective mouthguard.
- (b) In any case where the user suffers from a pre-existing dental condition for which the mouthguard did not afford or could not responsibly have been expected to provide sufficient protection.

This warranty is not available and affords no protection, indemnity or compensation for root canal, orthodontic or cosmetic treatment or the bridging or anchoring of the user's teeth.

### 5. Other conditions

Except as set out on this warranty, Madison Sport PTY LTD accepts no other or further

liability for any damages or loss (including indirect, consequential or economic loss) and whether arising in contract, tort or otherwise. This warranty is the only express warranty, guarantee or condition given by Madison Sport PTY LTD with respect to the mouthguard, no other guarantee, warranty, condition or representation is given or made, express or implied, other than a warranty, condition or guarantee implied or mandated under applicable federal, state or territory legislation. In any case in which a restriction or modification is permitted under applicable legislation, Madison Sport PTY LTD limits its liability to the fullest extent possible, in particular to the replacement of the mouthguard or reimbursement of its cost to the user.

### 6. Governing Law

This warranty is governed by the laws in force in QUEENSLAND and the parties submit to the non-exclusive jurisdiction of the courts of QUEENSLAND and the COMMONWEALTH OF AUSTRALIA.
