**Methods and materials for containment and cleaning up**

- Spill** : Stop leak if without risk. Move containers from spill area. Prevent

Contain and collect spillage with non-combustible, absorbent material e.g. sand, earth, vermiculite or diatomaceous earth and place in container for disposal according to local regulations (see Section 13). ### Precautions for safe handling

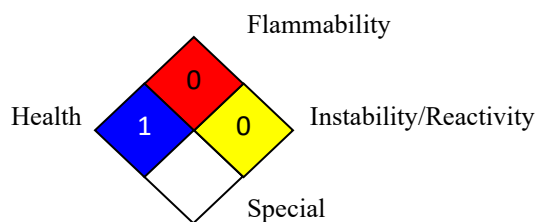
