Methods and materials for containment and cleaning up

Precautions for safe handling

Appropriate engineering controls : Good general ventilation should be sufficient to control worker

Environmental exposure controls : exposure to airborne contaminants. 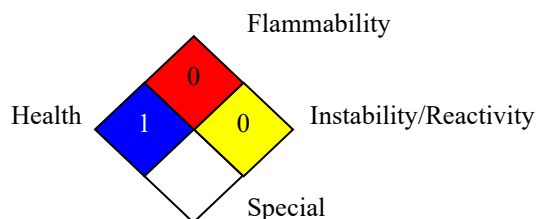
