#### Terms & Conditions:

#### Payment:

All new customers must first prepay all orders by credit cards, cashiers check, money order, or wire transfer. Personal or Company checks are not accepted. All orders must be prepaid. Parts in stock will be sent immediately unless otherwise specified by the customer. All back orders must be cancelled by the customers or will be automatically shipped upon their availability.

#### Availability of Parts:

Bay Speed Aerokit Llc. will only hold parts for 3 business days, from the last conversation with the customer. If payment is not received with in three days, we cannot guarantee the availability of the parts. Bay Speed Aerokit Llc. will place and hold the order based on a first come first serve basis. With parts that are in limited production, Bay Speed Co. can only hold the part for three working days. If the customer chooses not to ship the part within three days, Bay Speed Co. has the right to sell the part to another customer unless customer make full prepay in advance before three day holding period expires.

#### Back Orders:

If Bay Speed Aerokit Llc. is unable to immediately fill the entire order, the balance of the shipment will be placed on back order. Parts in stock will be sent immediately unless otherwise specified by the customer. All back orders must be cancelled by the customers or will be automatically shipped upon their availability.

#### Order Placement:

We do our best to service our customers in the accuracy of orders, and we encourage customers to do a FAX ORDER or EMAIL ORDER ONLY. If the customer chooses not to do a fax order or email order, in the event of a wrong order, it is the customer's responsibility, and Bay Speed Co. will not be held liable. No refunds, returns, or exchanges on incorrect or miscommunicated phone orders.

#### Shipping Damage:

Damage may occur occasionally in transit. Shipments are NOT automatically insured by the carrier and insurance is NOT included on the standard freight quote. Customer must request freight insurance with their order. Any damage in shipment is the responsibility of the carrier; therefore the purchaser must make all damage claims directly to the carrier. In case of damage, retain all cartons, packing materials and damaged merchandise for the carrier to inspect. Never refuse shipment or return it without approval since your right to make a damage claim may be denied by the transit company if you do so. If the damage is apparent upon receipt, accept the merchandise and note the damage and irregularities (such as crushed, torn, or broken packing) on the Freight bill and have the driver sign it as verification. All parts must be inspected before the driver leaves or else claims can be denied by the transit freight company. If any damage has occurred, note it on the driver's bill and have him initial it and make a copy for your records. All disputes as to the settlement amount or manner should be addressed with the carrier. Bay Speed Aerokit Llc. under no circumstances shall be liable for the damage merchandise or for subsequent settlement of the claim with the carrier.

#### Returns:

Special order items cannot be cancelled or returned. NO RETURNS ON BODYKITS, FENDERS, SPOILERS, HOODS. All other returns must be approved by Bay Speed Aerokit Llc. prior to being returned. All items must be returned within 10 days after being delivered. Any items received after 10 days or without approval from Bay Speed Aerokit Llc. will be refused and returned to the purchaser at his/her own expense. All returns must be in unused, unaltered, and unpainted condition. All returns must be sent shipping prepaid. Any returns sent freight collect will be refused and returned to the purchaser at their own expense. All returnable items must be carefully packed in original packing (or better) if the original packing is no longer in good condition. Purchaser is advised to insure the returned goods for their full value for his own protection, since neither Bay Speed Aerokit Llc. nor the shipping company would be responsible for any damage or loss in shipment. Refunds will not be issued on returned merchandise damaged on the way back to Bay Speed Aerokit Llc. #### **Quality Levels and Degree of Difficulty of Installation:**

Bay Speed Aerokit Llc. is in no way responsible in the explanation to wholesale account customers on the quality of body kits. It is the wholesale customer's responsibility to explain to their retail customer the quality of level of body kits. If a kit is less expensive, then the body kit may not fit as good as a higher quality kit. The kits will probably need more prepping and extensive work on the less expensive body kits. Body kits differ in quality depending on the manufacturer of the product. Fiberglass body kits are sold "AS IS" and it is the customers responsibility to know all of the work involved in the installation process. Understand fiberglass kits are not always direct bolt-ons. Sometimes it is possible a fiberglass kit may need a lot of prep work including filling gaps, trimming, or grinding. Bay Speed Aerokit Llc. recommends that the retail customer seek an experienced custom shop to do the install on body kits and know all the procedures, of installing fiberglass kits. We do not recommend a collision shop to do installs on body kits, they are only experienced on installing OEM parts that are direct bolt-on and do not know the procedure of installing fiberglass body kits.

#### Other Restrictions

Some Items are for of-road use only. Customer is responsible for checking state and federal laws before ordering. Buyer fully understands that all body kits, fenders, hoods and spoilers are sold "as is" with no warranty. Buyer also understands that due to strict U.S. Federal and State Safety crash guidelines, BAY SPEED AEROKIT LLC. is not responsible or liable for any damage or possible injury incurred upon possible accidents due to driver error, incorrect installations, bad judgment (cracking or breaking your parts). Buyer understands that all body kits/fenders/hoods/spoilers may need modifications for correct fitment such as removal of safety reinforcements, removal of factory bumper lights/side marker indicators, shaving, molding, etc. Because many of these kits are prototyped and used on non-USA vehicles that have much less safety standards/requirements in their respective countries of origin, BAY SPEED AEROKIT LLC. is not liable for any illegal street use of these parts.

#### Carbon/Fiberglass Hoods

All aftermarket hoods will require hood pins and are for off-road use only. No exceptions. Carbon fiber hoods are lightweight and may fly open while driving if not properly secured. We strongly recommend the use of hood pins in addition to the included latch. Bay Speed Co. is not responsible for any damage caused by an improperly secured hood.
