Notes:

- The objective of this test report is to verify the technical performance of the facepiece in the described configuration (provided with a bandana). The facepiece of this test report is a variant of a model already certified by ITALCERT. Taking into account the similarities between the two models and the previous tests carried out during the certification of the original model, the test of inward leakage has been performed with reduced sampling.

- The tests in compliance with EN 149:2001+A1:2009 standard have been performed at ITALCERT laboratory.

The inward leakage tests have been performed using the test method with sodium chloride according to paragraph 8.5 of the reference standard.

During the performing of the test the human subjects made the following exercises:

- a) Walking for 2 minutes without head movement or talking.
- b) Turning head from side to side (approx. 15 times), as if inspecting the walls of a tunnel for 2 minutes.
- c) Moving the head up and down (approx. 15 times), as if inspecting the roof and floor for 2 minutes.
- Reciting the alphabet or an agreed text loud as if communicating with a colleague for 2 minutes.
- e) Walking for 2 minutes without head movement or talking.

Requirements for FFP3

The total inward leakage shall be not greater than 5% for at least 46 out of 50 individual exercise results. At least 8 out of the 10 individual wearer arithmetic means for total inward leakage shall be not greater than 2%.

This test Report must be published only in full.

The test results obtained refer exclusively to the samples submitted to examination. From this data, no declaration concerning the compliance of the series production to the test sample can be desumed.
