## Conditioning

Immediately prior to testing the sample of Fabric, Q: 5710 was subjected the water soaking procedure described in Annex D, and then dried at indoor ambient conditions. It was then subjected to 24 hours in specified conditions, having a temperature of  $(23\pm 2^{\circ}\text{C})$  and relative humidity of  $(50\pm 5^{\circ})$ .

## Procedure

The specimens were mounted over fillings of combustion modified high resilience foam filling of density of approximately 36 Kg/m<sup>3</sup>.

## Results

The following test results relate only to the ignitability of the combination of materials under the particular conditions of test; they are not intended as a means of assessing the full potential fire hazard of the materials in use.
