



PRIVACY POLICY

Quasset B.V., Seinstraat 4, 1223 DA Hilversum, The Netherlands ("Quasset") is the co-organizer of the HOIS Seminar (hereafter "Seminar").

You may visit the website without providing Personal Data, as defined below. However, should you wish Quasset to provide the Services, as defined below, you may be required to allow Quasset to process, transfer and store your Personal Data. Protecting your Personal Data and in collecting, processing, transferring and storing your Personal Data is very important to Quasset. Accordingly, Quasset is committed to complying with the applicable data protection laws, in particular the EU General Data Privacy Regulation ("GDPR"). These Terms inform you of Quasset's policies regarding the use of your Personal Data. The following terms shall have the meanings as defined below:

1. "Personal Data" means any information with which you can be personally identified. This includes your name, your postal or e-mail address, and other information as required or requested to allow Quasset to perform the Services, as defined below.
2. "Services" means Quasset's (a) processing of your registration as an attendee, exhibitor or press attendee at the symposium ; (b) sending you newsletters, e-mails and similar with regard to the symposium, partners and related events/offerings; (c) identifying an appropriate partner for your needs upon your request; (d) analysis of the results of any Quasset or Quasset partner you may participate in; (e) provision of courses; or (f) sales of merchant Quasset.

COLLECTION OF PERSONAL DATA

3. Quasset collects Personal Data from you when you register for the Symposium, update your profile, or request other Services via the Website. To register with Quasset, you must provide your name, email address, company name, billing address. From time-to-time Quasset or one of its partners may ask you to respond to surveys or other requests for information.
4. All Personal Data that Quasset collects may be used by Quasset only with your consent for the purpose for which Quasset has expressly requested such information and subject to this Privacy Policy or as other Quasset expressly agreed by you.
5. You may change your profile information at any time. However, we may be unable to update or delete any of your Personal Data that has been shared with a third party as permitted in this Privacy Policy, but you will be able to do so pursuant to such third-party data privacy terms.

COMMUNICATIONS

6. Quasset may send you service-related announcements and emails from time to time. Quasset may also use your Personal Data for a mobile event app, to send you e-newsletters, updates and communications about Quasset.

LOG FILE DATA & WEB ANALYTICS

7. Like most website operators, Quasset collects log-file data from all visitors to the Website. This information may include the browser you are using, the internet address from which you linked to the Website, the operating system of your computer, the unique IP address of the computer you used to access the Website, and usage and browsing habits. Quasset uses this information to help diagnose and troubleshoot server malfunctions, to analyse trends, track user movement in the aggregate, and gather broad demographic information. We may also use individual information we collect through web logs to send you targeted offers and other communications.

DATA PRIVACY STATEMENT FOR THE USE OF GOOGLE AdSense

8. This Website might make use of Google AdSense, a web service to allow inclusion of commercial



advertisements from Google Inc. ("Google"). Google AdSense uses so-called "Cookies", text files, which are stored on your computer and enable an analysis of your use of the website. Google AdSense also uses so-called "Web Beacons" (invisible graphics). Information, such as the number of visitors to this site, can be analysed through use of these Web Beacons. Quasset uses firewalls and intrusion-detection devices that are designed to defend against hackers and notify Quasset if any attempts are made to compromise the Quasset network. Quasset regularly reviews additional software upgrades to enhance these security measures.

LEGAL MATTERS; SAFETY

11. Quasset may, without your consent, access and disclose your Personal Data, any communications sent or received by you, and any other information that Quasset may have about you or your account as may be permitted or required by law (including, but not limited to, by court order or subpoena), or to prevent or investigate suspected fraud, violations of our Terms of Service, or activity that reasonably appears to Quasset to be illegal or may expose us to legal liability. Additionally, Quasset may disclose your information in situations that it, in good faith, believes to be emergencies involving potential threats to the physical safety of any person or property if Quasset believes that your information in any way relates to that threat.

CHANGES TO THE PRIVACY POLICY

12. Quasset may change this Privacy Policy from time to time. The most recent version of the Privacy Policy will always be posted on the Website, with the "Effective Date" posted at the top of the Privacy Policy. Quasset will inform you if it substantially modifies the way Quasset handles your Personal Data by posting a notice on the Website. Should you not agree to any changes, you may change your account preferences or delete your account. However, in the latter case you will no longer receive information from Quasset regarding the Seminar or any related topics, and Quasset may not be able to provide the Services to you.
