MANUFACTURER'S LIMITED WARRANTY

AKA Outdoor Ent. warrants that your recreational table will be free from defects in materials and workmanship for a period of one (1) year from date of purchase under normal operating conditions and use. In the event that the recreational table exhibits a defect in materials or workmanship, a warranty claim must be received by **AKA Outdoor Ent.**, together with proof of purchase (indicating date purchased), within 1 year of purchase date.

THIS WARRANTY IS SUBJECT TO THE FOLLOWING TERMS AND CONDITIONS:

- 1. Vinyl playing surface and rails are not warranted against fading and discolouration, which will occur from exposure to sunlight. To maintain a uniform appearance, it is recommended that the table be positioned outdoors in a location where no one portion of the table top receives significantly greater long term exposure to the sun than other portions of the table top, and that the table top be covered when not in use.
- Aluminum frame and legs will not rust, but will discolour through oxidization over time, and this warranty does not cover any such oxidization. Under no circumstances should the recreational table be placed or left in standing water.
- 3. Leaf staining and bird droppings will come out with a general purpose cleaner or scrubbing with a soft cloth and mild soapy water. Under no circumstances should the vinyl playing surface or rails be scrubbed or scraped with a hard material such as a paint scraper, knife, trowel, wire brush, or abrasive, and use of any such tools will void this warranty.
- 4. Table top will not warp under normal operating and storage conditions. Table top must be kept level, both when in use and in storage, and should be checked and adjusted for level periodically to account for settling or frost heaving of the ground or patio surface and movement of the table. Leaving the table out of level for prolonged periods will void this warranty. In particular, the table should never be stored or left for a prolonged period on its side, end or overturned, and any such storage will void this warranty. Sharp objects should be kept away from the vinyl playing surface at all times, and any puncture in the vinyl playing surface or underwrap will void this warranty. Table must be covered when not in use in winter. Changes in temperature will result in temporary movement of rails, and visual patterns on vinyl playing surface, but they will return to original state as temperature stabilizes.
- 5. The recreational table is designed for playing table games at home, and should never be used as a platform, stand for heavy objects or serving table. Climbing, standing, jumping, sitting or lying upon the table will void this warranty. Any commercial use of the table will void this warranty.
- 6. Table should never be located near a barbeque, fire pit or other source of heat.
- 7. Repair or replacement of the vinyl playing surface, rails and other parts of the recreational table should only be done by an authorized service representative of the manufacturer, and any attempt at repair or replacement of any components by anyone not authorized by the manufacturer will void this warranty.
- 8. Care should be taken not to damage the plastic ball baskets, which are not warranted against damage. Ball baskets should never be used for any other purpose such as drink holders
- 9. All accessories, such as play kit and hockey insert game that may be sold with the recreational table are not warranted. All accessories should be stored indoors when not in use.
- 10. Warranty is for repair of the defect, or replacement should repair not be practical, in the sole determination of the manufacturer or its authorized service representatives, and excludes all shipping charges.
- Children should be supervised when playing with or in the vicinity of the recreational table.

AKA Outdoor Ent. shall not be liable for consequential damages arising from any defects in design, materials or workmanship including, without limitation, damage to property, personal injury or death. Under no circumstances should the recreational table be used otherwise than for its intended purpose.
