

## Terpenoid Analysis

Terpene analysis utilizing gas chromatography-flame ionization detection (GC-FID).

Method: OSP 1192 - Analysis of Terpenoids by GC-FID

### 1 Limonene

A monoterpene with a fragrance that can be described as orangey, citrusy, sweet and tart. It is most commonly found in nature as D-Limonene and is a primary contributor to the distinct scent of orange peels, from which it is commonly derived. Found in numerous pines, red maple, silver maple, aspens, cottonwoods, hemlocks, sumac, cedar, junipers...etc.

### 2 $\alpha$ Bisabolol

A sesquiterpene alcohol with a fragrance that can be described as floral, peppery, sweet and clean. Found in chamomile, figwort, yarrow, skullcaps, lavender, ironwort, germander...etc.

### 3 Terpineol

A monoterpene alcohol with a fragrance that can be described as fresh, floral, piney, woody with a hint of lime. The most common isomer is  $\alpha$ -Terpineol. Found in melaleuca, pine, bitter orange, skullcap, tea plant...etc.
