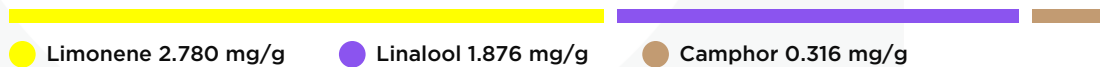

1 Limonene

A monoterpene with a fragrance that can be described as orangey, citrusy, sweet and tart. It is most commonly found in nature as D-Limonene and is a primary contributor to the distinct scent of orange peels, from which it is commonly derived. Found in numerous pines, red maple, silver maple, aspens, cottonwoods, hemlocks, sumac, cedar, junipers...etc.

2 Linalool

A monoterpene alcohol with a fragrance that can be described as spicy, waxy, citrus and floral. It is commonly used as an insecticide against cockroaches, flies, fleas and other insects. Found in basil, lavender, cinnamon, hops, mugwort, goldenrods...etc.

3 Camphor

A monoterpene ketone with a pungent fragrance that is as reminiscent of mothballs. It is commonly derived from *Cinnamomum camphora*, from which it lends its name. It is a constituent of turpentine and has been used by certain cultures as an embalming fluid due to its antimicrobial effects. Found in camphor laurel, rosemary, East African camphorwood, goldenasters, coriander, feverfew, tarragon, nutmeg, sweet wormwood, yerba buena, mountain mint, hyssop, forskohlii, tansy, thyme, turmeric...etc.
