PREPARATION

ALL SURFACES MUST BE CLEAN AND DRY.

Cracks, damaged joints and spalls should be free of dirt, oils, dust, latent and loose materials. Shot-blast or grind the concrete surface before applying a grout coat. Square cutting of the repair area is optional.

Spalls, Cracks & Joint Repair Mortar

First make dry mix, 1 part Patch Crete Pure to 2 to 3 parts selected aggregate. Place 2 parts of dry mix into mixing container, add 1 part B of polymer mix to wet out dry mix than add 1 part A of polymer. Mix for about 1 minute. Additional dry mix can be added. For deep repair, up to 2 parts pea gravel can be added. When making a mortar, keep it fluid and wet (not dry/stiff) so it is self-priming. Place mixer into repair.

ROUGH, PITTED & FINE/SMALL SURFACE GROUT

Add 0.5 to 1 part Patch Crete Pure to 1 part polymer depending on surface profile. Trowel tightly over surface.

BASIC MIXING TOOLS

- 1. Several medium size mixing bucket
- 2. Several measuring cups
- 3. Margin trowel
- 4. Steel Edge Scraper or Hand trowel

EXTRA MATERIALS (NOT SUPPLIED)

- 1. Several grit sizes of sand & aggregate for matching concrete aggregate
- 2. Color pigment, dry or liquid for matching concrete color

RECOMMENDATIONS

- 1. Be sure aggregate is dry. Moisture will cause repair to swell or bubble.
- 2. For deep repairs fill in layers. Sprinkle sand to refusal over mortar between layers so surface inside the repair is not wet. Once reacted and hard, continue with the repair.
- 3. Allow to cure for about 30 minutes before grinding/polishing surface.
- 4. Patch any large/deep spalls & cracks first before doing a surface grout.
- 5. Perform Much-up or Sample for matching
