PRODUCT COMPOSITION

<u>DESCRIPTION: Stone Edge Surfaces Hairline Crack Fill</u> is a just add water, no primer required, heavily polymerized concrete hairline crack fill that is used to fill, fix, patch and repair hairline surface cracks that may appear as the concrete, Stone Veneer dries, or concrete overlay cures, settles, dries, age, or due to concrete movement over time. Hairline Crack Fill is also used in the topical coloring process when coloring decorative concrete as a Color Enhancer or Accent Enhancer, to add mottling and realism. Hairline Crack Fill s a dry polymer and cementitious mix that comes in a 10 lb pail.

MIXING AND APPLICATION

MIXING INSTRUCTIONS AS Hairline Crack Fill: Mix Hairline Crack Fill with cool, clean, potable water. Add approximately 2 - 3 OZ (.059 - .88 Liters) of water per 1 (one) Dry Cup (4.22 L) of mix. NOTE: More or less water may be needed depending on air temperature, water mineral content, humidity, and soft or hard water. Water chemistry varies by location, and amount of water you will need may be slightly less or more than what is listed. Mix for an estimated 3-5 minutes after all water and dry material have been added. APPLICATION METHOD AS A HAIRLINE CRACK FILL: Hairline Crack fill is applied into and over the cracks in the same general way you would grout tiles where you apply pressure and push or force the mix down as deeply as you can go into the crack to fill it, which will leave excess material all around the lip of the crack as well. Then wipe away the excess material off the surface, only leaving the crack fill in the crack itself. MIXING AND APPLICATION INSTRUCTIONS AS Accent or Color Enhancer: Follow the same instructions above except for the amount of water. As Color Enhancer, you need a thinner more liquid mix. Mix 3 - 4 OZ (.88 - .118 Liters) of water per 1 (one) Dry Cup (4.22 L) of mix. APPLICATION METHOD AS A COLOR ENHANCER: Hairline Crack Fill as a Color Enhancer is applied with a Cellulose Sponge lightly dipped in the Hairline Crack Fill mixture. Scrape off all excess material from the sponge. Do not Push the sponge onto the surface, you just need a light hazing of mixture on the high spots. "Lightly" drag the sponge over "just the high spots" of the stamped or carved concrete "before" applying your colors or antiquing. Let Hairline Crack Fill dry, and then apply your topical colors as normal. The areas where you applied Hairline Crack Fill as a Color or Accent Enhancer will mottle the colors slightly and add extra shading and realism. COLORING: Hairline Crack Fill can be integrally colored (mix the water with the color first, then add to the mix. Topically Color as you would any other concrete s

PRODUCT CAUTIONS

When Applying Hairline Crack Fill, you will apply it like you are grouting tile...make sure to clean all excess product off the surface of the substrate and around the edges of the crack. When using as a color enhancer, use only a cellulose sponge to help reduce dripping and DO NOT use a sprayer! Hairline Crack Fill / Accent Enhancer is to be applied sparingly with the intent to just highlight and lightly coat random areas or the higher portions (the tips and edges that stick out the furthest) and is not meant to cover the entire surface with a layer of accent enhancer.

PRODUCT CLEANABILITY

With overlay and crack fill products...the smoother the finished texture, the easier the surface is to clean, but there is a loss of skid resistant properties. Cleaning and disinfecting compounds and cleaning techniques can affect the color, gloss, texture and performance of the system. As the precautionary step, Stone Edge Surfaces recommends that the end-user test their cleaning and disinfecting compounds on a non-conspicuous area before use.

PRODUCT SHELF LIFE

If properly stored, the expected shelf life can exceed 6 months. However, it is recommended that product be used as soon as possible after delivery. Rotate stock to use oldest inventory first. Store under roof and keep dry.
