

Rubbing, Smoothing and Reprofiling Repair Mortar

**TECHNICAL DATA SHEET** 

### DESCRIPTION

Superior Wall Finish is a single component, cement based material specially formulated for rubbing, smoothing, and reprofiling vertical concrete surfaces.

### USE

Superior Wall Finish is a trowel, roller or brush applied mortar designed to eliminate small concrete surface blemishes, rough areas, bug holes and form marks on poured walls, tilt-up and precast. Superior Wall Finish develops a high bond strength to the concrete and is not sensitive to water after curing. Applications are interior or exterior on above grade vertical surfaces.

# PROPERTIES

#### Note:

When testing the field mixed material, other factors such as variations in mixing, water content, temperature and curing conditions should be considered.

# **Estimating Guide**

30 lbs. (13.6 kg) will cover 36 sq. ft. (4.4 sq. m) at approximately 1/8 in. (0.32 cm) thickness.

10 lbs. (4.5 kg) will cover 12 sq. ft. (1.5 sq. m) at approximately 1/8 in. (0.32 cm) thickness.

### STORAGE

When stored in a dry facility, shelf life of unopened bags is 18 months for the 10 lbs bags and 12 months for the 30 lbs bags. Excessive temperature differential and /or high humidity can shorten the shelf life expectancy. Store in a cool, dry area free of direct sunlight.

### **Surface Preparation:**

The substrate must be sound and free of all foreign material including curing compounds, bond breakers, oil, grease, paint, etc. Surfaces should have a slight profile to ensure good adhesion. All surfaces to be repaired should be in a saturated surface-dry (SSD) condition with no standing water on the surface.

### Water Requirements:

Per 30 lb (13.6 kg) bag: Trowel applied: 8.5 US pints (4.0 L), Brush or Rolling: 11.5 US pints (5.4 L)

Per 10 lb (4.5 kg) bag: Trowel applied: 2.8 US pints (1.3 L), Brush or Rolling: 3.8 US pints (1.8 L)

# Mixing

Mix by hand or with a slow speed drill in a clean container. Mix only what can be placed in 20 minutes. Do not mix more than 3 minutes. Do not over mix or re-temper.

### Placement:

When placing by trowel, sponge float, brush or roller force the material into cracks, voids bug holes and honeycomb areas to eliminate any voids. Superior Wall Finish retains its moisture prior to curing and will spread easily. Product can be placed vertically up to 2 in. (5.1 cm) thick and overhead up to 1/8 in. (0.32 cm) thick.

### Finishing:

Superior Wall Finish may be rolled, brushed, smooth troweled or sponge floated prior to material setting hard and may be sanded after it hardens.

### CURING

Dry times will depend on applied thickness and weather conditions. In extreme hot and windy conditions moist curing may be required.

### **CLEAN UP**

Use water prior to material setting hard. Hardened material requires abrasive removal methods.

### LIMITATIONS

#### FOR PROFESSIONAL USE ONLY

Prepackaged material segregates while in the bag, thus when mixing less than a full bag it is recommended to first agitate the bag to assure it is blended prior to use.

Do not place at temperatures below 40°F (5°C) or if the temperature is expected to drop below 40°F

(5°C) in the next 24 hours

In hot weather follow ACI Committee 305

recommended procedures

Not for use as a parge coating or stucco type application

Protect from rain or excess water for 1 hour.
