PRECAUTIONARY STATEMENTS

Hazards to Humans and Domestic Animals

CAUTION: Harmful if swallowed, inhaled, or contact is made with the skin or eyes. May cause irritation to eyes, skin, lungs or stomach. Avoid contact with skin, eyes and clothing. Avoid breathing vapor or spray mist. Avoid using product in a manner as to directly, or through drift, expose workers or other persons. Always follow precautionary statements on the label of the active ingredient that is to be used with JetShield. Always consult the Material Safety Data Sheet for specific instructions.

Personal Protective Equipment (PPE): Applicators and other handlers must wear goggles or a facial splash shield; chemical resistant gloves, such as nitrile rubber \geq mils or neoprene rubber $>+$ mils; coveralls or long-sleeved shirt and long pants; shoes plus socks. Wash the outside of gloves before removing. Wash thoroughly and change into clean clothing.

FIRST AID

IF IN EYES: Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing. If eye irritation persists, get medical advice or attention.

Pesticide manufacturers may recommend a rate of nonionic surfactant to be used with their product. Follow the pesticide or active ingredient label recommendations on the use of nonionic surfactants. However, if the pesticide or active ingredient label does not prohibit the use of a nonionic surfactant, JetShield should be applied at the rates listed below. Careful observation of spray performance in a trial application with combinations of chemicals to be applied is recommended to determine proper and efficient surfactant rates.

For use as an inert ingredient in combination with permitted active pesticide ingredients.
 As a spray adjuvant for pesticides: (Herbicides, Fertilizers, Insecticides/Miticides, Fungicides):

Turf (including but not limited to golf courses, commercial, residential, sports turf, sod farms, parks): Use at 6-16 fl oz per 100 gal. In backpack sprayers use at 0.06-0.16 fl oz per one gallon.

Ornamentals (including but not limited to greenhouses, nursery, landscapes, transplanted crops, trees): Special caution should be used when applying over ornamentals. Plant safety may be a concern and user should test appropriately to confirm acceptable safety. Use at 6-16 fl oz per 100 gal. In backpack sprayers use at 0.06-0.16 fl oz per one gallon.

Industrial (including but not limited to vegetation management, roadsides, railroads, range and pasture): Use at 6-16 fl oz per 100 gal. In backpack sprayers use at 0.06-0.16 fl oz per one gallon.

Pest Control: Use at 6-16 fl oz per 100 gal. In backpack sprayers use at 0.06-0.16 fl oz per one gallon.

Mixing Instructions

1. Fill tank to 2/3 to ¾ full of water. If foaming is anticipated, add an anti-foaming agent before pesticide and JetShield
2. Add pesticide as directed by pesticide label
3. Continue agitations
4. Add JetShield and continue filling tank while maintaining agitation.

Spray coverage and drift control:

To optimize spray coverage or deposition, and to reduce drift, include Droplex® adjuvant.
