Mystic WSP Blue when added to lakes, ponds, or water hazards, conveniently transforms pale, dirty, or off-color water into a natural appearing healthy Blue. Mystic WSP Blue may be used to color ornamental lakes, ponds, fountains, water hazards, and other contained bodies of water.

Mystic WSP Blue may also be used as a Spray Pattern Indicator to reduce over application and skips. Mixes with water based pesticides and fertilizers.

DIRECTIONS FOR USE READ ENTIRE LABEL BEFORE USING

Lake and Pond Dye: Use 1 pack per acre 1-2 feet deep. User may want to evenly space the addition of product in the treated area to ensure quicker, more even coverage. Color may vary with application rate and frequency as well as environmental conditions. Mystic WSP Blue may be applied to areas used for irrigation, but not for direct human consumption. Mystic WSP Blue should not be applied to streams, rivers, out flows, or water not completely controlled by the user. Swimming and other recreation sports are approved during and following use of this product. However, wait until product has uniformly dispersed before participating in approved activities. Fish, waterfowl, and animals are not harmed by normal use of this product. Wait 24 hours after treatment before adding additional packs for desired color.

Spray Pattern Indicator: Use 1-2 packs per 100-150 gallons of water.
