PRECAUTIONARY STATEMENTS

FIRST AID

STORAGE AND DISPOSAL

GENERAL INFORMATION

PostFlight is a tank cleaner. PostFlight will clean the inside of spray tanks, including deactivating some pesticide residues. PostFlight will clean pigment, iron and other stains on sprayers as well. PostFlight can even be used to clean pigment and other residues off of other objects such as sprinkler heads.

DIRECTIONS FOR USE READ ENTIRE LABEL BEFORE USING SHAKE WELL

This product is not intended for use on edible food crops.

Tank Cleaning Directions:

For Large tanks (100-300 gallons): Add 50 gallons of water into the tank. Then add 1 pint (16 fl oz) of PostFlight.

For Small Tanks (<100 gallons): Fill tank half full of water. Add 1 oz of PostFlight for every 3 gallons of water.

Once solution is in tank turn agitation on, with spray boom/nozzle closed, allowing the solution to circulate throughout the spray system. For smaller tanks without agitation, physically agitate the mix. For best performance make sure entire tank gets washed in the solution, including the cover, and sprayed down with high pressure spray. Once the solution has run for at least 5 minutes, open the spray boom/nozzle to allow the solution to run through the nozzles. Take care to properly dispose of spray solution according to local, state and federal guidelines. After solution has been run out of sprayer, fill sprayer with cold water and run through same procedure as above. A second rinse with water is recommended if switching from a chemical that could cause a detriment to your next spray application.

When using PostFlight to clean tanks with built-up residue from extended use, allow the cleaning solution a longer time to act.

For small parts, nozzles, screens, etc. create a solution of 1 oz of PostFlight in 1 gallon of water. Allow parts to soak for at least 30 minutes. Light bushing may be necessary to remove built up residues. Rinse parts thoroughly under running water after soaking.

Pigment/Stain Cleaning Directions:

PostFlight is ready to use. No dilution needed. It is best applied with a spray applicator such as a hand spray bottle.

Apply PostFlight liberally, wait approximately 2-5 minutes, brush the surface and rinse.

Using warm water will improve cleaning performance.

For more concentrated, older stains, reapplication may be necessary.

Note: Not to be used on marble, soft stone, granite, unfinished aluminum, or other porous surfaces. If concerned about damage to surface, test small, inconspicuous area prior to using on entire surface.
