GENERAL INFORMATION

Mystic HC was developed for use with all pesticides, fertilizers, and other plant protectants. If the applicator does not have experience using this product, a phytotoxicity and jar test should be performed to confirm plant safety and tank mix compatibility with a specific spray mix.

DIRECTIONS FOR USE **Shake Well Before Using**

Turf (Including but not limited to golf courses, commercial, residential, sports turf, sod farms, parks): 4-8 fl oz per acre or 6-25 fl oz per 100 gallons. In a backpack sprayer, use 1/8 – 1/4 fl oz per gallon. When using higher carrier volume per acre or applying to thin stands, use the highest label rate to achieve uniform coloration.

Ornamentals (including but not limited to greenhouses, nursery, landscapes, transplanted crops): 4-8 fl oz per acre or 6-25 fl oz per 100 gallons. In a backpack sprayer, use 1/8 – 1/4 fl oz per gallon. When using higher carrier volume per acre or applying to thin stands, use the highest label rate to achieve uniform coloration.

Industrial (including but not limited to vegetation management, roadsides, railroads, aquatics, range and pasture): 4-8 fl oz per acre or 6-25 fl oz per 100 gallons. In a backpack sprayer, use 1/8 – 1/4 fl oz per gallon. When using higher carrier volume per acre or applying to thin stands, use the highest label rate to achieve uniform coloration.

Pest Control: 6-25 fl oz per 100 gallons. In a backpack sprayer, use 1/8 – 1/4 fl oz per gallon. When using higher carrier volume per acre or applying to thin stands, use the highest label rate to achieve uniform coloration.

Other Crops (including but not limited to herbs, vegetables, fruit, nuts, hops): 4-8 fl oz per acre or 6-25 fl oz per 100 gallons. In a backpack sprayer, use 1/8 – 1/4 fl oz per gallon. When using higher carrier volume per acre or applying to thin stands, use the highest label rate to achieve uniform coloration.

Thoroughly clean sprayer, tank and hoses after each use.
