#### PRECAUTIONARY STATEMENTS

#### GENERAL INFORMATION

Mystic SPI Blue is a dye designed to be used in sprayers to indicate where product has been applied. This formula is specifically designed to dissipate after the user is done spraying so that others are not able to see the spray application.

#### USE RATES

Area to be Applied	Rate per 100 Gals of Solution
Gravel, bare ground, parking lots, stations, pumping stations, driveways or pole yards	6 – 12 oz
Roadside ditch banks, highway rights-of-way, fence lines, or county weed control use.	10 – 16 oz
Sod, lawns, parks, schools, cemeteries, landscaping industrial, or general edging use	12- 16 oz
Utility rights-of-way, power or pipeline corridors, brush forestry or railroad use	16 – 32 oz

#### For Turf Use

The rate charts give the applicator an estimated range of Mystic SPI rates to apply per acre. Generally 8-16 ounces per acre or 1/4 to 3/4 ounce per 1,000 square feet are recommended. The listed rates also account for turf color.

Greens	8 oz.	12 – 16 oz
Fairways and Lawns	12 oz.	16 – 20 oz
Roughs	16 oz.	20 – 24 oz

### For Industrial and Forestry Use

Mystic SPI is a temporary colorant used for marking spray applications. By adding Mystic SPI to the spray solution, spray applicators can accurately and uniformly apply pesticides and liquid fertilizers. Mystic SPI is compatible with most chemical compounds. Mystic SPI is economical, environmentally safe, and is easily removed from application equipment. The chart below provides the applicator with an estimated range of Mystic SPI rates to add to each 100 gallons of spray solution. Experiment with the volume of spray solution and rate of Mystic SPI added to each 100 gallons to establish an economical and effective rate. Use the higher rate for the darkest and most easily visible spray pattern.

### For Hand Held Sprayers

Tank Size	Suggested Rate
1 gallon	$\frac{1}{4}$ - $\frac{1}{2}$ oz
3 gallons	$\frac{3}{4}$ - 1 $\frac{1}{2}$ oz
5 gallons	1 $\frac{1}{4}$ - 2 $\frac{1}{2}$ oz
