1.0 Introduction

This document is the FAA Approved Model List for STC No. SA00344BO for installation of the Parmetheus Plus LED Landing and Taxi Light Assemblies. Revisions to this AML must be coordinated between the STC holder and the responsible ACO. Revision requires an FAA approval.

2.0 Certification Basis
