

## **GOLO Gives Sweepstakes Official Rules**

NO PURCHASE OR DONATION NECESSARY TO ENTER OR WIN. A PURCHASE OR DONATION DOES NOT IMPROVE YOUR CHANCES OF WINNING.

This Sweepstakes is governed exclusively by the laws of the United States. You are not authorized to participate in the Sweepstakes if you are not located within the fifty (50) United States or the District of Columbia.

Participation constitutes entrant's full and unconditional agreement to and acceptance of these Official Rules.

**DATES OF SWEEPSTAKES:** The **GOLO Gives** Sweepstakes ("Sweepstakes") begins **on January 1, 2023 at 12:00:01am Eastern Time ("ET")** and ends **on December 31, 2023 at 11:59:59pm ET.** ("Sweepstakes Period"). The Sweepstakes is sponsored by GOLO, LLC. ("Sponsor").

**ELIGIBILITY:** The Sweepstakes is open only to legal residents of the fifty (50) United States or the District of Columbia, who are eighteen (18) years of age or older or the age of majority in their state of residence as of the date of entry (the "Entrant"). Void outside of the fifty (50) United States, the District of Columbia, and where prohibited, taxed or restricted by law. Employees, officers, and directors of Sponsor, and all of their respective parents, subsidiaries, members, divisions, affiliates, advertising, promotion, and fulfillment agencies ("Sponsor and Promotion Parties"), and those individuals who are immediate family members of Sponsor and Promotion Parties, or persons living in the same household as Sponsor and Promotion Parties, are not eligible to participate in the Sweepstakes. "Immediate family" means parents, siblings, children and spouse. Void where prohibited. All federal, state, and local laws and regulations apply.

You may submit an entry up to once per month (i.e. up to once in each of January, February, March, April, May, June, July, August, September, October, November, and December 2023) during the Sweepstakes Period using either entry method.

## 1. DONATION:

- a. Collect your clothing donations and weigh them on a scale.
- b. After weighing take a picture of your donation.

  - Your name
  - City & State
  - Where you donated (charity or shelter name)
  - Number of clothing pounds donated
- d. (Optional and not required to enter the Sweepstakes) Join, or login to, our private Facebook Group here https://www.facebook.com/groups/1736485829924717 and create a new post with your donation photo and include the hashtag #GOLOgives

Assuming an entry meets all the above requirements, it will be counted towards entry for the month in which it was submitted.

**2. WRITE-IN:** To enter without making a donation, send your name, address, phone number, e-mail address, and birth date and mail to: **GOLO Gives** Sweepstakes, 700 Prides Crossing, Suite 304, Newark, Delaware 19713. This mail-in entry must be postmarked by the last day of the applicable month. Multiple entries submitted or completed by anyone other than the Entrant are void. No mechanical reproductions will be accepted. Write-in entries must contain all entry fields outlined above; otherwise, they are void and will not be eligible to win. Each envelope/postcard is considered one (1) entry into the Sweepstakes.

No other methods of entry are accepted. Sponsor is not responsible for incorrect, inaccurate or incomplete entry of information by participants; lost entries or transmissions, interrupted or unavailable network, server, or other connections; scrambled transmissions or other errors or problems of any kind whether mechanical, human, or electronic, technical malfunctions or the computer hardware, software, or any combination thereof; or problems associated with any virus or any other damage caused to participants' systems. Entries submitted by anyone other than the Entrant are void.

## **PRIZES:**

Monthly Winner: One (1) winner will be selected each month of the Sweepstakes Period ("Monthly Winner"). The Monthly Winner will receive one bottle of Release® and one bottle of Go-Digest® supplements with a total approximate retail value ("ARV") of \$74.90.

Grand Prize Winner: One (1) Grand Prize Winner ("Grand Prize Winner") will be randomly selected from all eligible entrants at the end of the Sweepstakes Period. The Grand Prize Winner will receive a \$250 Visa gift card. Standard gift card terms and conditions apply.

Total ARV of all prizes to be awarded is approximately \$324.90.

All prizes will be awarded. Limit of one (1) prize per person/household. No substitution or transfer of any prize or election of cash in lieu of any prize by Winner will be permitted. Sponsor reserves the right to substitute any prize of equal or greater value. Prizes are nontransferable. No more than the stated number of prizes set forth in these Official Rules will be awarded. **SELECTION OF WINNERS:** On or about the fifth business day of the following month for Monthly Winners and on or about January 11, 2024, for the Grand Prize Winner (collectively "Winners"), Sponsor will select, via a random drawing, Winners from all eligible entries received during the relevant period. Non-winning entries in the monthly drawings will not roll over to subsequent monthly drawings. Selected Winners will be notified by email and/or telephone within 14 days after the drawing.
